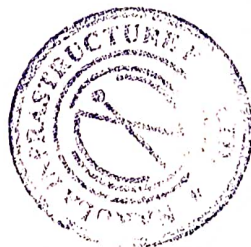
Respected Sir,

I wish to draw your kind attention to the fact, that our Company (Narula infra (P) Ltd) has a mobile tower under your jurisdiction in village Poradi, where our technician Mr. Goutam Gope is posted for regular technical work, but unfortunately land owner cum MTA Mr Sukhendu nath obstruct him to do his work from last six month. Our registered MTA Sukhendu nath s/o Gouranga nath not allowing Mr Goutam for his regular work, which effect local people of that area not getting frequent service.

Many official of our Company tried to persuade the MTA to allow Goutam Gope to go to tower for regular maintenance work, but he did not allow, the reason best know to him. At present the tower has been lying unintended for a long time as a result a large number of people are affected and Company facing huge financial loss. <sup>on 23/03/23 at about 4 p.m.</sup> last week Goutam Gope the technician tried to enter at tower premises considering the gravity of the situation but Sukhendu nath of poradi tower did not allow him to entered and also threatened him not to come again. Under the situation I request you to kindly take necessary action as per law treating as a FIR.
