That ~~here~~ thereafter the accused person entered into my house by breaking the door and Prabir Mahato assaulted with axe in the leg and I sustained bleeding injury on my ~~leg~~ leg and ~~hise~~ and ~~hize~~ and cry and I along with my husband Madan Bauri to save us and inside the room shut down my daughter ~~xManakx~~ Manika Mahato to phone before the Purulia (M) P.S. by her mobile phone and hearing the sound of said phone the accused persons named above left the place.

That after this incident narrated the incident before the Purulia(M) P.S. and thereafter we ~~ent~~ went to Sadar Hospital Purulia for treatment and the attended doctor of Sadar Hospital i.e. emergency ward and after treatment my ~~said~~ I admitted into Sadar Hospital, Purulia and my treatment going on the said hospital Purulia.

4.. That this complainant informed the matter to Purulia(M) P.S. orally later on sending the petition with Regd. Post as well as Superintendent of Police Purulia but got no relief from there, so the
