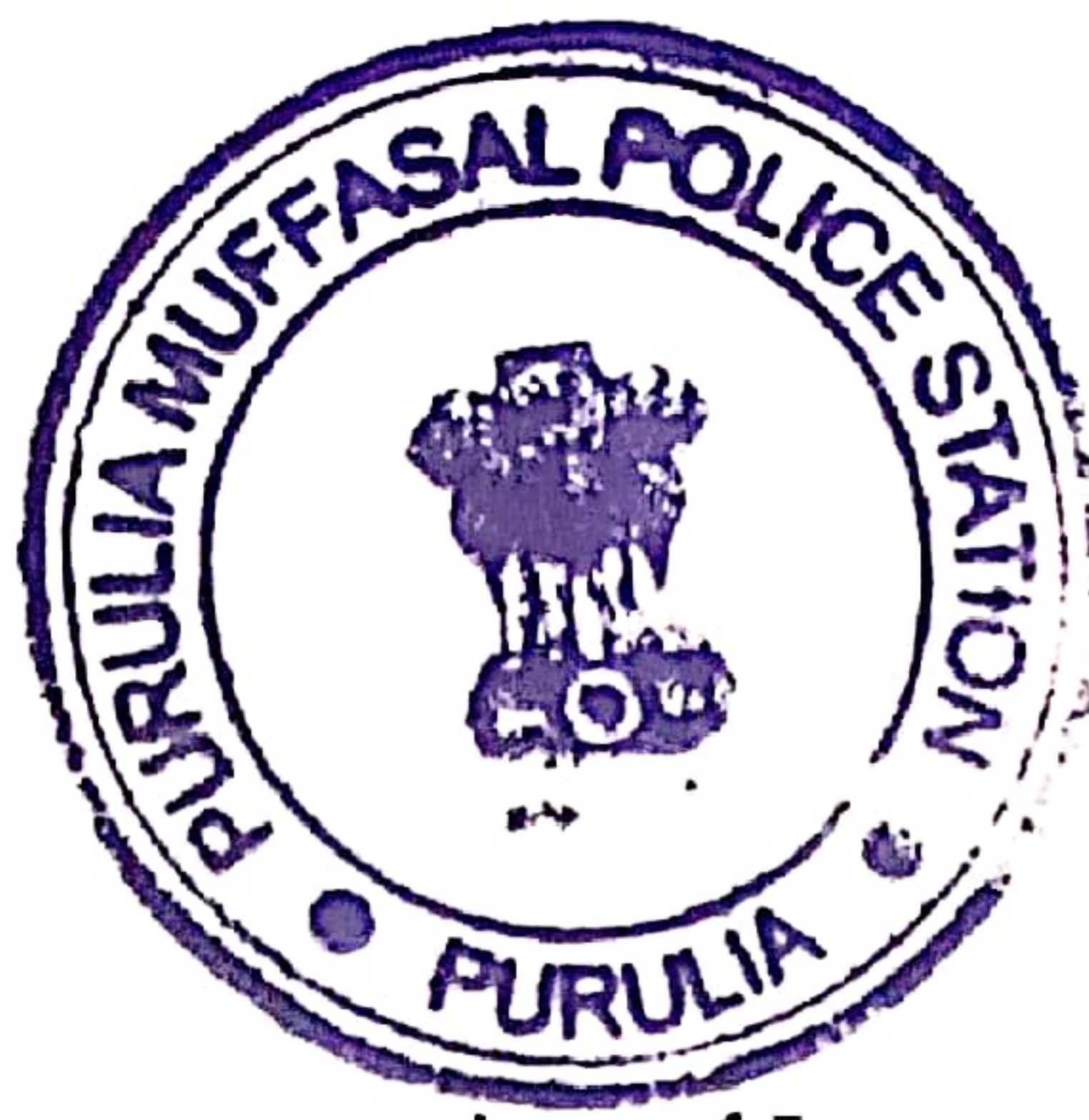

Sub: Prayer for lodged FIR as per section of Law.

Sir,

In producing herewith the seized vehicle (Tractor) having Reg. No. WB 55B 5578 loaded with sand approx 100 cft sand with proper Seizure list.

The fact of brief is that today (15.04.2023) at 08.25 hrs I along with force C/2402 Binayak Dubey & NVF- 571 Bhaktaranjan Paramanik both of Purulia (M) PS left the PS for patrolling duty vide Purulia (M) PS CC No- 1178/23 and GDE No 614 Dt. 15.04.2023 at Bankura road area. During my mobile duty, I received from my source at about 14.05 hrs that a suspicious tractor loaded with sand was coming from Kansai river of Chakirban Ghat. Accordingly, after collecting the information I contacted with I.C Purulia (M) PS over the telephone and brief down the matter to him and as per the instruction given by him, I along with force proceeded towards the Chakirban Ghat to work out the information. During the time proceeding towards the Chakirban Ghat I along with force intercepted the vehicle (Tractor) having registration No- WB 55B 5578 attached with Trolley loaded with Sand approx 100 Cft at about 15.15 hrs at Old Manbazar Road on his way towards Dabar Balarampur to Purulia near Jawahar Navadoya Vidyalaya, Purulia. When I tried to check the documents along with all concerned papers of sand he, immediately tried to fled away the spot, I along with force caught the driver. After that I enquired the driver he eventually disclosed his identity as Biswapati Mahato (30 Yrs) S/o- Lt. Bibhuti Bhusan Mahato of Vill- Chakirban, PS- Purulia (M), Dist- Purulia. But he did not give any satisfactory answer regarding this Tractor or sand. So I, seized the (tractor) having Reg. No. WB 55B 5578 attached with Trolley loaded with Sand 100 Cft. (approx) under proper seizure list. The seizure was done in between 15.35 hrs and 15.55 hrs in presence of available witnesses duly signed by them and alleged driver. So I eventually without seeing any way I arrested the alleged driver after maintaining all formalities regarding arrest also informed him and his relatives regarding the ground of arrest. The arrest was done at 16.05 hrs.

The owner of the said Tractor as well as driver loaded said sand by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that driver in cahoots with the owner of the vehicle and others procured the said sand from Kansai River Chakirban Ghat under Purulia (M) PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. Thereafter, I brought the said seized tractor and arrested driver to Purulia (M) PS.

Under the above facts and circumstances kindly take lawful action against the owner and the arrested driver of the seized vehicle (Tractor) having Reg. No- WB 55B 5578 under proper section of Law.
