

Most respectfully sheweth:-

- 1. That your petitioner/complainant is father of Late Ganapati Dubey and he presently residing at Vill + Po :- ShibdihDist :- Purulia
- 2. That witness is resident of Vill-Chirka Dist Purulia and he is a civic volunteer of police.
- That your petitioner's son Ganapati Dubey used to go daily to Chasmore vegetable market to buy vegetables and sale them in nearby villages by his cycle.
- 4. That on 23/11/2022 at around 8.00 am in the morning, Ganapati Dubey met with an accident near Chasmore by a motor bike which bearing registration no WB56F 0975.
- 5. That the driver of the motor bike coming from Chasmore towards Purulia drove his bike rashly and negligently hit Ganapati Dubey from backside as a result Ganapati Dubey fell down and got severe injury on his body.
- 6. That a civic volunteer namely Shri Hiralal Mahato residing near chirka village was present at the accident spot at the time of accident.
- 7. That some person present around the accident spot immediately took Ganapati Dubey to Purulia Deben MahatoSadar Hospital for medical treatment.
- 8. That on the same day 23/11/2022 the Doctor of Deben Mahato Sadar Hospital referred Ganapati Dudey to Rajendra Institute of Medical Science, Ranchi for better treatment as his condition was very serious.
- 9. That during treatment of Ganapati Dubey at Rajendra Institute of Medical Science, Ranchi he died on 28/11/2022.
- 10. That this incident highly shocked your petitioner and his family and as a result your petitioner gone through serious illness and mental trauma therefore they could not lodge a complaint/FIR against the driver immediately against driver of Vehicle no: WB56F 0975.
- 11. That after 3 months being recovered from illness on 1st week of march 2023 your petitioner approached local police station Purulia(M) to lodge a complaint/FIR against the driver but Purulia (M) police station refused to lodge a complaint/FIR.





