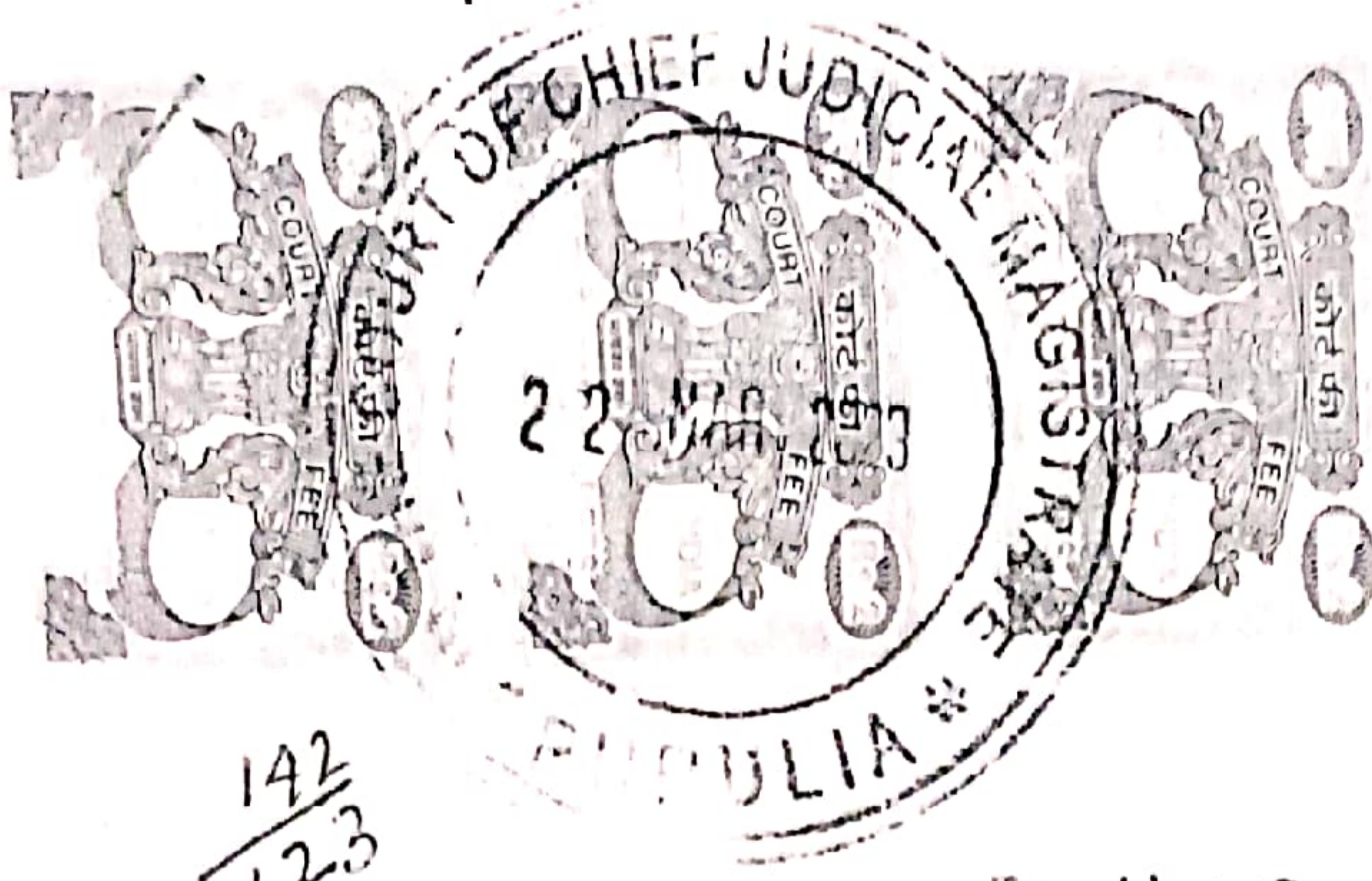

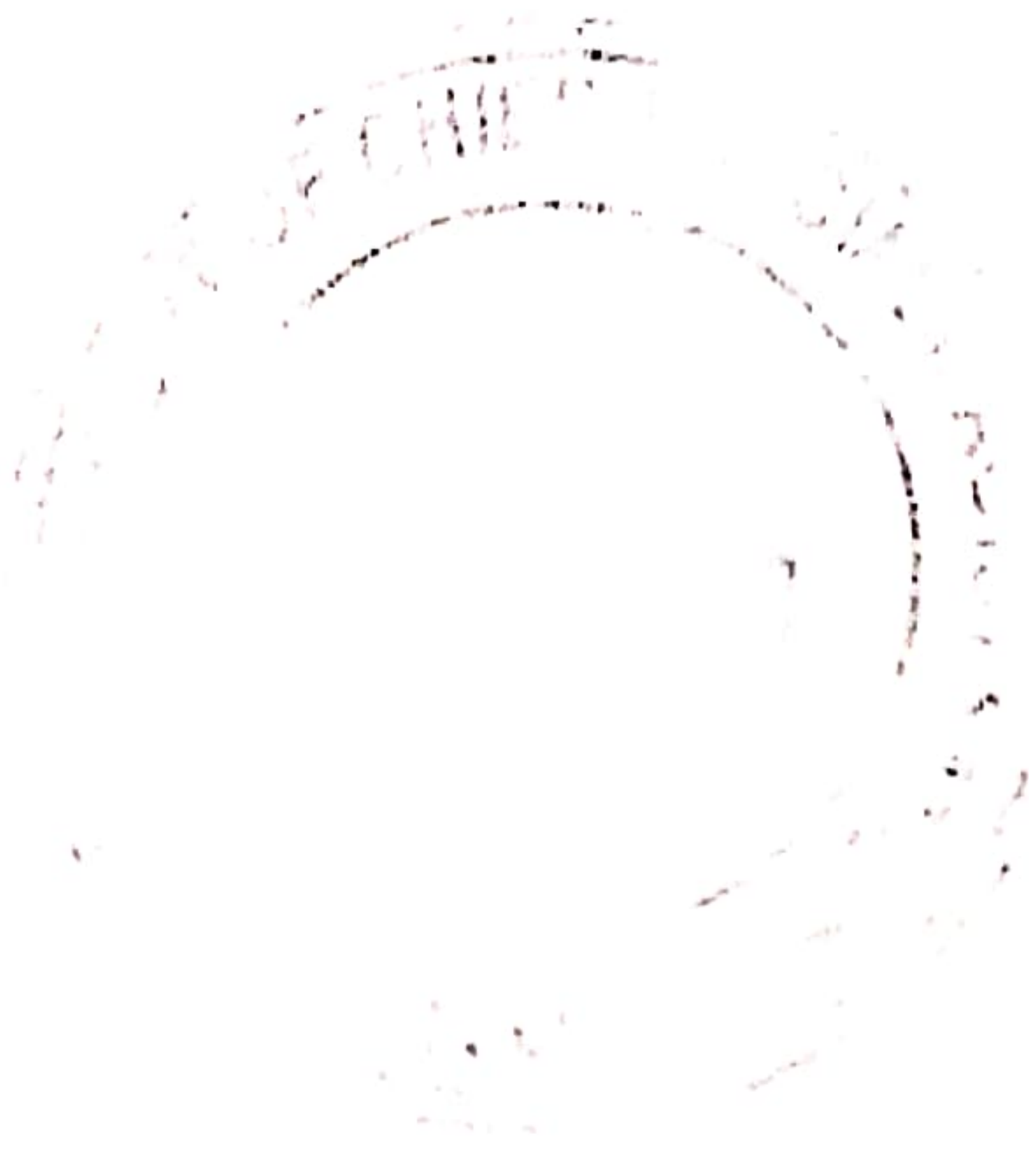

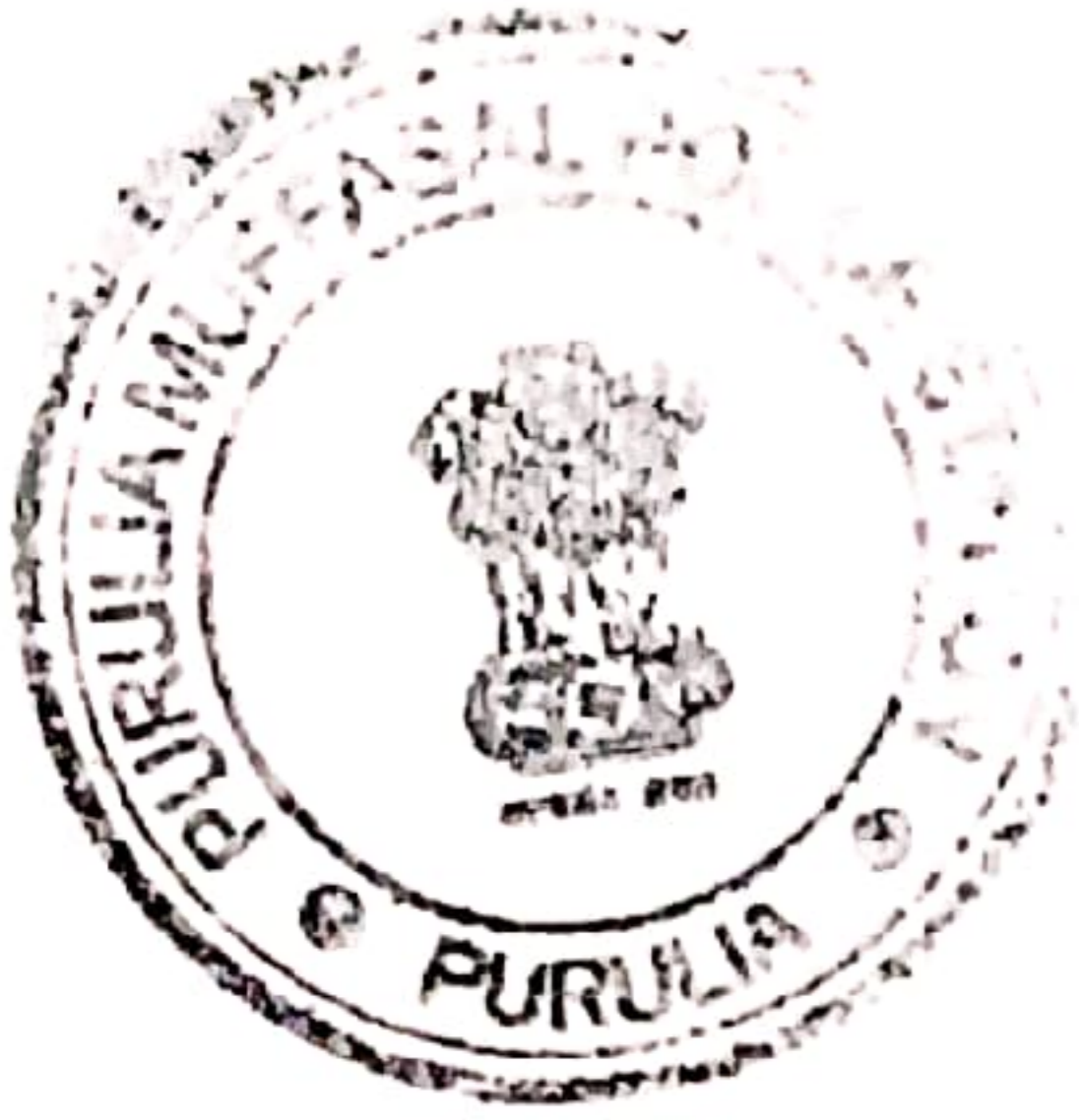

6..That if they have succeeded to fled away my 7(Seven) female buffalos from my custody then I have suffering moneytary loss ~~xxx~~ ,my selling milk business break down ~~and some~~ and I have suffering mental and financial both-~~xxx~~

7..That thereafter the complainant informed the matter to Purulia(M) P.S.and later on Registered with A/D as well as Superintendent of Police, Purulia but got no relief from there end so, the complainant to take shelter before the Ld.Court for end of justice.

Under this circumstances it is prayed before your Honour to accept the petition u/s 156(3) Cr.P.C.and directed to O/C Purulia(M) P.S.to treat it as a F.I.R.and be pleased to pass necessary order.
