Sub: Prayer for lodge FIR under proper section of law.

Sir,

In producing herewith the arrested driver namely Trilochan Mahato (40 Yrs) S/o- Lt. Jadab Mahato of Vill- Sindri, PS- Purulia (M), Dist- Purulia along with seized vehicle (Tractor) having registration No- WB 55B 2164 attached with Trolley loaded with sand approx 100 cft, Seizure list, Memo of Arrest in respect of the above noted person before you.

The fact brief is that today (21.04.2023) at 10.35 hrs I along with C/- 1410 Saroj Patra & C/- 154 Rajib Nag both of Purulia (M) PS left the PS for mobile duty vide Purulia (M) PS C.C No 1262/2023 Dtd. 21.04.2023 and GDE No- 915 Dtd. 21.04.2023 in PS area. During my day mobile duty, I received information at **15.05 hrs** that a suspicious tractor loaded with sand was coming from the Kansai river side (Katabera Ghat) towards Sindri village. Subsequently, I along with force proceeded towards Katabera village to work out the information. While I, along with the force, arrived near Sindri Chasmorh at **15.25 hrs** found that one tractor was proceeding towards Sindri Chasmorh. I along with the force intercepted the vehicle (Tractor) having registration No- WB 55B 2164 attached with Trolley loaded with Sand and I found the vehicle as well as goods identical as I received prior information. On being asked, the driver of said vehicle disclosed his identity as Trilochan Mahato (40 Yrs) S/o- Lt. Jadab Mahato of Vill- Sindri, PS- Purulia (M), Dist- Purulia. I asked the driver of said Tractor to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle was not able to produce any kind of documents in respect of the Tractor and the loaded sand. I repeatedly asked the driver to produce the valid papers but he stated differently in different times. The incoherent statement of the driver purported to be suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the said Tractor by illegal means for selling the same to make their own profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Kansai River (Katabera Ghat) under Purulia (M) PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I seized the (Tractor) having registration No- WB 55B 2164 attached with Trolley loaded with sand approx 100 cft under proper seizure list in presence of available witnesses duly signed by him. The arrest was made in between **15.35 & 15.55 hrs**. Also arrested the involved driver namely Trilochan Mahato (40 Yrs) S/o- Lt. Jadab Mahato of Vill- Sindri, PS- Purulia (M), Dist- Purulia after informing him of the ground arrest and issued Memo of Arrest. The arrest was made at **16.05 hrs**. Thereafter, I brought the seized tractor along with the arrested driver to Purulia (M) PS compound.

Under the above facts and circumstances I therefore pray before you kindly take lawful action against the owner and the arrested driver namely Trilochan Mahato (40 Yrs) S/o- Lt. Jadab Mahato of Vill- Sindri, PS- Purulia (M), Dist- Purulia of the seized vehicle (Tractor) having registration No- WB 55B 2164 under proper section of Law.
