In producing herewith the arrested involved driver namely Ranjit Mahato (23 Yrs) S/o- Mantu Charan Mahato of Vill- Kantabera, PS- Purulia (M), Dist- Purulia along with seized vehicle (Tractor) having registration No- WB 55B 4307 attached with Trolley loaded with sand approx 100 cft, Seizure list, Memo of Arrest in respect of the above noted person before you.

The fact brief is that today (21.04.2023) at 08.45 hrs I along with C/- 178 Tulsi Mahato & C/-2078 Haripada Das both of Purulia (M) PS left the PS for mobile duty vide Purulia (M) PS C.C No 1259/2023 Dtd. 21.04.2023 and GDE No- 907 Dtd. 21.04.2023 in PS area. During my day mobile duty I received the FIR copy in c/w Purulia (M) PS Case No- 90/2023 Dtd. 21.04.2023 U/S- 379/411/120B IPC & 21(1) (4) of Mines & Minerals (R&D) Act 1957 and found I.C Purulia (M) PS endorsed me for its investigation. After investigation of this case, I along with force returning to PS at 18.15 hrs received information that a suspicious tractor loaded with sand was coming from the Kansai river side (Katabera Ghat) towards Imondih village. Subsequently, I along with force proceeded towards Imondih village. While I, along with the force, arrived near Imondih morh at 18.35 hrs found that one tractor was comming towards Imondih village morh. I along with the force intercepted the vehicle (Tractor) having registration No- WB 55B 4307 attached with Trolley loaded with Sand and I found the vehicle as well as goods identical as I received prior information. On being asked, the driver of said vehicle disclosed his identity as Ranjit Mahato (23 Yrs) S/o- Mantu Charan Mahato of Vill- Kantabera, PS- Purulia (M), Dist-Purulia. I asked the driver of said Tractor to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle was not able to produce any kind of documents in respect of the Tractor and the loaded sand. I repeatedly asked the driver to produce the valid papers but he stated differently at different times. The incoherent statement of the driver purported to be suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the said Tractor by illegal means for selling the same to make their own profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand form Kansai River (Katabera Ghat) under Purulia (M) PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I seized the (Tractor) having registration No- WB 55B 4307 attached with Trolley loaded with sand approx 100 cft under proper seizure list in presence of available witnesses duly signed by him. The arrest was made between 18.45 & 19.05 hrs. Also arrested the involved driver namely Ranjit Mahato (23 Yrs) S/o-Mantu Charan Mahato of Vill- Kantabera, PS- Purulia (M), Dist- Purulia after informing him of the ground arrest and issued Memo of Arrest. The arrest was made at 19.15 hrs. Thereafter, I brought the seized tractor along with the arrested driver to Purulia (M) PS compound.

Under the above facts and circumstances I therefore pray before you kindly take lawful action against the owner and the arrested driver namely Ranjit Mahato (23 Yrs) S/o- Mantu Charan Mahato of Vill- Kantabera, PS- Purulia (M), Dist- Purulia of the seized vehicle (Tractor) having registration No- WB 55B 4307 under proper section of Law.
