I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1/c & 1/d of the electricity Act 2003, Amendment of 2007 as stated here under.

On 27/04/2023 at 12.50 Hrs. I, Sri Subhajit Pratihar, A.E & Station Manager, Purulia Customer Care Centre (CCC) along with Biswanath Barui (AE S&LP attached to Purulia Regional Office WBSEDCL), Chinmay Maity (JE Purulia CCC), Dayamay Mahato (Sr TSH Purulia Region Office WBSEDCL), Sankar Ch Mahato (ACM Purulia Regional Office WBSEDCL) went to make an inspection to workout upon a source information regarding theft of electricity for domestic purpose at the domestic premises of Md Nowshad, Son of Md Jaan, resident of Nayabosti, JK College road, Purulia(T) PS, Dist Purulia.

During the time of inspection at the premises 1 nos of electricity meter was found having serial no B5108642 (Consumer id 202679686, Consumer Name- Md Nowshad).

It was observed that consumer Md Nowshad has made unauthorized use of electricity under section 135 1/c & 1/d by damaging the meter serial no B5108642 & uses electricity through the damaged meter as to interfere with the proper or accurate metering of electricity consumption & hence made unauthorized use of electricity under section 135 1/c & 1/d, hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using Fan 2 nos (60 watt each), Light 160 watt (4x40 watt each), Fridge 130 watt.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the service lines from pole with the help of LT Mobile Van Team and removed & seized 1 nos of energy meter having serial no B5108642. Prepared Inspection sheet and seizure list duly signed by the accused.

The inspection team left the premises at about 13:15 Hrs on 27th April 2023.

The accused committed theft of electricity U/S 135 1/c, 1/d of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
