I Hemanta Kr. Sahababu (53 Yrs), S/o- Lt. Madan Mohon Sahababu of Vill- Jabarrah, PS-Para, Dist- Purulia, SI of Police of Tamna PS, Dist- Purulia along with force returned at PS and in producing herewith 03 (three) seized vehicles (Tractor) i.e. (i) One blue colour POWERTRAC 439 PLUS bearing Registration No. WB55A-6901, Chassis No. T053353950FF & Engine No. E3396907 attached with Trolley loaded with sand approx 100 Cft without number plate (ii) One red colour Mahindra 415 DI bearing Registration No. WB55B-2316, Chassis No. MBNAAAVAPJRH02877 & Engine No. RJH4YBA4766 attached with Trolley loaded with sand approx 100 Cft. without number plate and (iii) One red colour Mahindra 275 DI SP PLUS without number plate bearing Chassis No. MBNTFAEDBNRC00844 & Engine No. RNC7EBN0887 attached with Trolley loaded with sand approx 100 Cft without number plate along with 03 (three) arrested accused driver namely (i) Munna Bouri (20), S/o- Lt. Rampada Bouri of Vill- Lagda, PS- Purulia (M), Dist- Purulia [Driver of vehicle (Tractor) having Reg. No. WB55A-6901] (ii) Rabi Gope (31 Yrs), S/o- Chintu Gope of Vill- Baligara, PS- Tamna, Dist-Purulia [Driver of vehicle (Tractor) having Reg. No. WB55B-2316] and (iii) Mukesh Bouri (27 Yrs), S/o- Nagen Bouri of Vill- Lagda, PS- Purulia (M), Dist- Purulia [Driver of vehicle (Tractor) having Chassis No. MBNTFAEDBNRC00844 & Engine No. RNC7EBN0887]. The fact of the case in brief is that on 03/04/2023 I along with C/2686 Ranabir Patra, C/2671 Prasanta Rajak, NVF-1075 Dhananjoy Rajak and NVF-635 Dhiren Daw of Tamna PS were on night mobile duty. During mobile duty on 04/04/2023 at about 02.15 hrs. when we reached near at Baligara village found that the above noted tractors were coming from Kansai river side under Tamna PS. On seeing the Police party driver of the said tractors stopped their tractors in a distance and they fled away after keeping the tractor near at Baligara village but we apprehend them after long chase. On demand the drivers of the said vehicle failed to produce any valid documents in respect of the said tractor. We searched the said tractor and found that the tractor was loaded with sand. We waited there some times and held an enquiry about the said tractor but none turned up and demanded as actual owner of the said tractor or the sand and ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So, seized the above noted tractors under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging driver from my source and brought the tractors at Tamna PS. So, its reason to belief that drivers and owners of the said seized tractors procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the above noted seized tractors.
