Sir,

In producing herewith seized one vehicle (Tractor) blue colour Sonalika, DI-35 bearing Registration No. WB55-5746, Chassis No. HZJSB145834/1A & Engine No. 3100FL82F146645 attached with Trolley loaded with sand without number plate. The fact of the case in brief is that on 02/04/2023 I along with C/1084 Pradyut Ghosh and NVT-1095 Tanuram Mahata of Tamna PS were on night mobile duty. During mobile duty on 03/04/2023 at about 01.25 hrs. when we reached near at Dumurdih village found that the above noted tractor was coming from Bhandarpuara side under Tamna PS. On seeing the Police party driver of the said tractor stopped his tractor in a distance and he fled away after keeping the tractor near at Dumurdih village. On demand the driver of the said vehicle failed to produce any valid documents in respect of the said tractor. We searched the said tractor and found that the tractor was loaded with sand. We waited there some times and held an enquiry about the said tractor but none turned up and demanded as actual owner of the said tractor or the sand and ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the tractor bearing Reg. No. WB 55-5746 attached with Trolley loaded with sand without any number plate under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging driver from my source and brought the tractor at Tamna PS. So it reason to belief that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the Tractor having Registration No. WB 55-5746 attached with Trolley loaded with sand approx. 100 Cft. without number plate.
