Sir,

I Hemanta Kr. Sahababu (53 Yrs), S/o- Lt. Madan Mohon Sahababu of Vill- Jabarrah, PS- Para, Dist- Purulia, SI of Police of Tamna PS, Dist- Purulia along with force returned at PS and in producing herewith one seized E-Rickshaw i.e. blue colour Toto without number plate having Model- AF-7 ECO, VIN No. M67AF7ECM21G05870, Motor ID No- AF7BLDC1000W/007169 loaded with 18 bag sand approx. 20 cft. along with 01 (one) arrested accused namely (i) Ashis Dhibar (27 Yrs), S/o-Sufal Dhibar of Vill- Amnala Namopara, PO- Raghunathchak, PS- Baraboni, Dist- Pachim Bardhaman A/P-Darjipara near Durga mandir, PS- Purulia Town, Dist- Purulia. The fact of the case in brief is that on 09/04/2023 I along with C/1084 Pradyut Ghosh and NVF-1095 Tanuram Mahata of Tamna PS were on mobile duty. During mobile duty on 09/04/2023 at about 15.15 hrs. when we reached near Kotlui village and found that the above noted Toto was coming from Kansai river side near Kotlui village under Tamna PS. On seeing the Police party driver of the said Toto stopped his Toto in a distance and he fled away after keeping the Toto near at Kotlui village. We apprehend the said driver after a hot chase. On demand the driver of the said vehicle failed to produce any valid documents in respect of the said Toto. We searched the said Toto and found that the Toto was loaded with sand. We waited there some times and held an enquiry about the said Toto but none turned up and demanded as actual owner of the said Toto or the sand and ascertained that the owner and driver of the said Toto loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So, seized the said Toto loaded with sand without any number plate under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging driver from my source and brought the Toto at Tamna PS. So it reason to belief that driver and owner of the said seized Toto procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the Toto without number plate having Model- AF-7 ECO, VIN No. M67AF7ECM21G05870, Motor ID No- AF7BLDC1000W/ 007169 loaded with 18 bag sand approx. 20 cft.
