Respected Sir,

I, Badal Paramanik S/O- Lt. Nirmal Paramanik of Vill+P.O- Biltora, PS- Purulia (M), Dist- Purulia, at present posted under Tamna PS, Dist- Purulia as SI of Police producing herewith one arrested accused person namely Sakhiram Mudi (35 yrs) S/O- Lt. Sanatan Mudi of Vill- Kothui Mudi Para, P.S- Tamna, Dist- Purulia with seized articles i.e. 1). One white colour plastic jerican containing approx 09 Ltrs. of ID Liquor, 2) 06 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample which was collected from seized articles Sl No-01 which were seized under proper seizure list.

I beg to submit that today (20.04.2023) during my PS area Evening mobile duty acting of a secret source information that one person selling I.D Liquor in his dwelling house at Kothui Mudi Para Village under Tamna PS, so myself along with i) C/2686 Ranabir Patra & ii) HG/1698 Haradhan Kumar both of Tamna PS came to the spot at about 18:45 hrs and found that one person is selling I.D Liquor to the others. Seeing the Police party, all customers fled way but we managed to apprehend the accused person namely Sakhiram Mudi (35 yrs) S/O- Lt. Sanatan Mudi of Vill- Kothui Mudi Para, P.S- Tamna, Dist- Purulia. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1). One white colour plastic jerican containing approx 09 Ltrs. of ID Liquor, 2) 06 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample collected from seized articles from Sl No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Sakhiram Mudi (35 yrs) S/O- Lt. Sanatan Mudi of Vill- Kothui Mudi Para, P.S- Tamna, Dist- Purulia as per proper section of law.
