The duly filled articles Rate Quoted should be submitted hard copy and soft copy in a sealed cover superscripting "**Tender for Miscellaneous Articles for the year 2023 – 2024**" and addressed to the Superintendent of Police, Purulia and same may be dropped in the "Tender Box" kept at Police Office, Purulia or should reach the office of the undersigned on or before 12.05.2023 by 11:30 hrs. The tender will be opened on 12.05.2023 at 16:30 hrs at the office of the undersigned where tenderers may like to attend.


1. The rate quoted should be inclusive of all taxes including GST, if any, and other charges, if any and be kept within the maximum retail price.
2. The Bidders shall arrange for all means of transport without claiming any extra payment from the Department.
3. No interest on the deposited Earnest Money shall be paid.
4. Any conditional bidding will not be accepted.
5. The earnest money is liable to be forfeited if the bidder fails to fulfil any of the terms and conditions.
6. All requisite documents shall invariably be submitted.
7. Failure to comply with any of the above instructions will disqualify of bidder from participating in the tender.
8. The Superintendent of Police, Purulia reserve the right to forfeit the earnest money deposit tendered by the contractor(s) or part thereof in the event of his / their failure to fulfil the conditions of the contract.
9. The Superintendent of Police, Purulia reserve the right to reject the lowest tender or any tender, if required, without assigning any reason thereof.
10. The Tender Inviting Authority may verify the original credentials & other original documents of the lowest tender, if found necessary, before issuance of the work order and the work order will not be issued in favour of the tenderer if it is found on verification that such document submitted by him is either manufactured or fabricated etc.
11. This contract/supplier shall not be sublet either wholly or in part without the prior written permission of the The Superintendent of Police, Purulia and for breach of this provision, The Superintendent of Police, Purulia may terminate the contract and forfeit the security deposit and the contractor shall have no claim for loss thereby resulting to him on any account whatsoever.
12. Delivery of goods shall not be considered complete until such goods have been inspected and passed by the officers appointed for the purpose.

Every Contractor / Supplier shall have to submit the attested copy of documents i.e. Sales Tax, Income Tax, P.Tax and GST Clearance Certificated and Tread License.

Every Contractor / Supplier shall have to deposit Earnest Money amounting Rs. 20,000/- (Twenty Thousand) only in form of DD in favour of Superintendent of Police, Purulia in the time of collect the articles list. Earnest money will be return date from 21/12/2023 to 30/12/2023.

The undersigned reserves the right to review / modify / extend the period of tender and also the authority to accept, reject any or all the tenders and/or negotiate with any tenders or divide the tendered articles for supply to different contractors/suppliers at any time without assigning any reason whatsoever.

All Tax deduct from bills as per Government Rules.




