




Uporjari, P.S. Arsha, District Purulia aged about 28 years beg to state that on 23/2/2023 in the afternoon I along with my wife Sarita Kumari (Orang) aged about 24 years, my sister-in-law Dibani Kumari (Orang) daughter of Bhola orang aged about 18 years and my female child Sakshi Kumari Orang aged about 5 months were going to my matrimonial home at Chandankiyari and we were waiting with my motorcycle Platina Bajaj,



registration number WB 56T 9114 at Boram more within Arsha police station. At about 5 P.M. two person riding on their motorcycle Honda Passion, registration number JHO 9M 9613 in a very high speed and negligently dashed my wife Sarita Kumari orang my sister-in-law Dibani Kumari (Orang) and my child Sakshi Kumari orang causing them seriously injured and my motorcycle has also damaged. After the accident at first with the help of some person there I took them to at first Sirkabad Hospital but the injuries sustained by them were very serious. They were referred to Purulia Sadar hospital and thereafter the doctor of purulia sadar Hospital referred them to Ranchi (RIMS) and they were admitted there and treatment were going on but unfortunately my wife Sarita Kumari Orang succumbed to death on 3-03-2023 and the injury of the left leg of my sister in law Dibani Kumari Orang was so serious that the leg has to be amputated and she and my child Sakshi kumari orang are still in the RIMS at Ranchi and treatment is going on.

That I was very busy for the injured the injured person I reported the incident before the officer-in-charge of Arsha police station District purulia. It is mentioned that necessary post mortem examination was performed in RIMS and the police officer of Baruatu police station started UD case along with PM report number 710/2023 dated 03-3-2023 and handover the same to me which I filed along with the complaint on 15/3/2023 to the officer-in-charge of Arsha police station. The police officer of Arsha P.S. told me that they were going to start necessary case against the driver and others of the offending motorcycle, but as no action taken. I sent the complaint again to the officer-in-charge of Arsha P.S. under registered post on 27/3/2023 and also made a representation of the same to the Superintendent of Police Purulia, who acknowledged the same but up till now i.e 11/04/2023 no action has been taken on my complaint. In such circumstances, I have been compelled to file this petition of complaint before your Honour.

The offence committed is very serious. One person died one persons leg has been amputated for the injury in the accident and my minor child is also suffering for her injuries still then the said police has not taken any action.

Unless a police case is started against the culprit and the actual culprit is brought to book, I will not get justice.

Under the circumstances I most respectfully beg to state that the officer-in-charge of Arsha police station be directed to start a necessary case against the culprit so that they may be tried in the court on my this complaint. I am a poor man having no means to fight the case on my own resource.
