Sub: To lodge FIR against owners and drivers of 03 (three) tractors having Reg. Nos. (i) WB55B/3443 (ii) WB55B/3242 and (iii) WB55B/5569 along with trolleys (sand approx 60 CFT each trolley).

Sir,

In producing herewith, 03 (three) tractors having Reg. Nos. (i) WB55B/3443 (ii) WB55B/3242 and (iii) WB55B/5569 (sand approx 60 CFT each trolley). Today on 09.04.2023 at about 15.15 hrs. during my mobile duty vide C.C no. 151 dtd.09.05.2023, I SI Nikhil Pratap Singh along with C/- 360 Satyajit Mandal of Kantadih Camp under Arsha PS, found the above noted 03 (three) tractors (i) WB55B/3443 (ii) WB55B/3242 and (iii) WB55B/5569 loaded with sand approx 60 CFT each trolley coming from Patuara village towards Dhanara morh under Arsha PS. Seeing the Police party the drivers of the said tractors leaving the tractors (loaded with sand in the attached trolley) at Dhanara morh, fled away. Police rushed to the tractors and detained the said tractors. Police searched the said tractors and found that the tractors are loaded with sand (approx 60 cft of each trolley) and also searched surrounding but could not trace out the persons & drivers of said offending tractors. Hence, I seized the above noted tractors along with trolleys and brought the tractors to Arsha PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted seized tractors having Reg. Nos. (i) WB55B/3443 (ii) WB55B/3242 and (iii) WB55B/5569 along with the trolleys for investigation.
