I do hereby lodge complaint empowered by enabling The Electricity Act - 2003, Subsequently Electricity (Amendment) Act-2007 to the effect that Sadhan kumar S/O - Suresh chandra Nath -
kumar was enjoying electricity unlawfully, i.e. hooking
from nearest L.T.O.H line and due to this reason
Has committed theft of electricity U/S 135 of the Electricity (amendment Act-2007).

And inspected his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L i.e U/S 135 (1) (a) was detected.

From the above arrangement he/she was using the following equipments

- 1) Fan 6 nos 80 watt each = 480 watt.
- 2) LED Bulb 10 nos 9 watt each = 90 watt.
- 3) Fridge 1 no 180 watt each = 180 watt.
- 4) water pump 1 no 375 watt each = 375 watt.
- 5) Total = 1125 watt.

Seizure list was prepared at the site and accused person refused to sign/signed.

The inspection team left the premises at 12.15 P.M on 11.05.2023
