- And inspected his/her premises. During inspection theft of electricity was detected I, e he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L I, e U/S 135 (1) (a) was detected.

From the above arrangement he/she was using the following equipments

- 2) LED light - 6 nos 9 Watt = 54 Watt
