Dear Sir,
I do hereby lodge complaint empowered by enabling The Electricity Act – 2003, Subsequently Electricity (Amendment) Act-2007 to the effect that *T.O.K. Krishnara Deogharia Sp-Late Murulichar Deogharia Was Temporarily electricity unauthorisedly i.e. hooking from nearest L.T.O.H line and due to this reason.*

Has committed theft of electricity U/S 135 of the Electricity (amendment Act-2007).

And inspected his/her premises. During inspection theft of electricity was detected i.e he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L i.e U/S 135 (1) (a) was detected.

From the above arrangement he/she was using the following equipments

- 2) *LED light - 6 nos. 9 watt = 54 watt.*
