

Sub: To lodge FIR against owner cum driver Prasanta Majhi (38 yrs) S/O Harekrishna Majhi of Vill-Patuara, PS- Arsha, Dist- Purulia and helper Anisul Ansary (35 Yrs) S/o Lt. Ali Hossain Ansary of Vill- Herodih, PS- Arsha, Dist- Purulia of one Sonalika DI-35 tractor having Engine No. 3100FL53G505040F3 and Chassis No. EZJSU508967SM with trolley loaded with sand (approx 60 CFT.)

Sir,

In producing herewith, 01 (one) Sonalika DI-35 tractor having Engine No. 3100FL53G505040F3 and Chassis No. EZJSU508967SM with trolley loaded with sand (approx 60 CFT). Today on 11.05.2023, received a credible source information that some persons are carrying sand loaded in a tractor towards Patuara village under Arsha PS. Accordingly, the fact was noted in GDE vide Kantadih camp PS GDE No. 230 dt. 11.05.2023 and myself along with C/356 Arup Malo and C/-360 Satyajit Mandal both of Kantadih Camp under Arsha PS left for holding raid vide Kantadih camp C.C No. 158 Dtd. 11.05.2023. When we reached near Patuara village under Arsha P.S, we found that the above noted owner cum driver and helper were unloading sand in a vacant land (just beside Patuara village road). We rushed to the spot and apprehended the above noted persons and detained the said tractor along with trolley loaded with sand (approx 60). We also found some sand approx 1000 cft already stocked there. I asked them to produce valid documents in support of carrying sand and stocked sand but they could not produce any such documents in respect of carrying sand and stocked sand (approx 1000 cft). Hence, I seized the above noted tractor along with trolley loaded with sand (approx 60 cft) and also the stocked sand amounting to approx 1000 cft under proper seizure lists and arrested the above noted involved persons. We tried to find local witnesses but none was found. We also searched the adjoining areas but found nobody for taking "Zimma" of the said sand (approx.1000 cft). So, I brought the said tractor along with trolley loaded with sand (approx 60 cft) and the arrested driver cum owner and helper to Arsha P.S.

Hence, I do hereby lodge this complaint against owner cum driver Prasanta Majhi (38 yrs) S/O Harekrishna Majhi of Vill- Patuara, PS- Arsha, Dist- Purulia and helper Anisul Ansary (35 Yrs) S/o Lt. Ali Hossain Ansary of Vill- Herodih, PS- Arsha, Dist- Purulia of above noted tractor along with the trolley loaded with sand for investigation.
