Helper of the said tractor namely Haladhar Mahato S/O Lt. Chakradhar Mahato both of vill- Katabera, PS- Purulia (M), Dist- Purulia, 4. Owner of tractor having Reg. No. WB55B/4715 and 5. Driver of said tractor namely Harmba Mahato (23y) S/O-Mathur Mahato of vill-Golbera, PS-Purulia (M), Dist-Purulia along with trolleys loaded with sand (approx 60 CFT of each trolley).

Sir,

In producing herewith, 02 tractor bearing registration no- (1) JH08H/3954 and (2) WB55B/4715 along with trolleys loaded with sand (approx 60 CFT of each trolley) and the arrested drivers and helper. To the effect that during my night mobile duty vide C.C No. 1232/23 & GDE No. 560 Dtd. 13.05.23 acting on source information, I ASI Tapan Kr. Mahata of Arsha PS along with (i) C/853 Kiran Ch. Murmu of Arsha P.S and (ii) C/959 Suman Kr. Das of SAP 7th BN camp at Arsha PS, Dist-Purulia reached at Bamundiha Ghat under Arsha PS on 14.05.23 at 07.35 hrs, we conducted raid at Bamundiha sand ghat on the Bank of River Kansai under Arsha PS and found 02 (two) tractors along with trolley loaded with sand was present at Bamundiha Ghat on the Bank of River Kansai. Seeing the Police party the drivers and helper of the above noted tractors tried to flee away, but we apprehended them. I asked them to produce valid documents in support of carrying sand, but they could not produce any valid documents. Hence, I seized the above noted tractors along with trolleys loaded with sand (approx 60 cft) of each trolley and arrested the drivers and helper namely 1. Sanjoy Mahato (22 yrs) S/O Haladhar Mahato (Driver) 2. Haladhar Mahato S/O Lt. Chakradhar Mahato both of vill- Katabera, PS- Purulia (M), Dist- Purulia (Helper), 3. Harmba Mahato (23y) S/O-Mathur Mahato of vill-Golbera, PS-Purulia (M), Dist-Purulia (driver) after issuing memo of arrest and brought the said tractors along with trolleys loaded with sand (approx 60 cft) of each trolley and the drivers and helper to Arsha P.S. As there is every reason to believe that the drivers, helpers and owners of the said tractors with ill motive were lifting and transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order as they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the 1. Owner of tractor bearing Reg. No- JH08H/3954, 2. Driver of said tractor namely Sanjoy Mahato (22 yrs) S/O Haladhar Mahato 3. Helper of the said tractor namely Haladhar Mahato S/O Lt. Chakradhar Mahato both of vill- Katabera, PS- Purulia (M), Dist- Purulia, 4. Owner of tractor having Reg. No. WB55B/4715 and 5. Driver of said tractor namely Harmba Mahato (23y) S/O-Mathur Mahato of vill-Golbera, PS-Purulia (M), Dist-Purulia along with trolley loaded with sand (approx 60 CFT) of each trolley for investigation.
