Sir.

In producing here with one arrested accused person Sudan Kumar (34 yrs) S/O Lt. Tulshi Kumar of vill- Uparkahan, P.S.-Joypur, Dist-Purulia along with following seized articles.

- 1) 12 Bottle of Kingfisher Beer, 650 ML each bottle & Rs- 125/- each bottle (125x12=1500/-) (One bottle taken out of the above as sample packed, labeled and sealed with sealing wax)
- 2) One white colour plastic container containing approx 16 ltrs. of ID liquor. (Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, ASI Nivas Ch. Mahato of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 19.05.23 at about 17.45 hrs. during my mobile duty at Arsha PS area, receive source information over telephone that the above noted accused has been selling ID liquor at Rangamati village near PHE pump house. On receiving the source information, I communicated with O/C Arsha PS over telephone and as per his direction I along with C/- 15 Sushanta Kr. Dey of Arsha P.S and C/- 227 Biswarup Mahato of SAP 7th BN work out the information vide Arsha PS C.C. No. 1278/23 dtd. 19.05.23. Reaching at Rangamati village Near PHE pump house at about 18.35 hrs and found 12 bottle of Kingfisher Beer and One white colour plastic container containing approx 16 ltrs. of ID liquor. Seeing the police party, all customer managed to flee-away, but we were able to apprehend the above noted accused person who was selling foreign liquor and I.D Liquor which he use to sell clandestinely to make his profit. On demand he failed to produce any valid documents in support of selling foreign liquor and I.D Liquor. Accordingly, I seized all those articles after preparing a proper seizure list and put label on all the seized articles from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses and one bottle of that seizure was taken as sample which was also duly labeled and approx 500 ml taken from the white colour plastic container as sample packed with sealing wax with label. It took time from 18.45 hrs. to 18.55 hrs. During interrogation he confessed his guilt. Therefore, I arrested him at 19.05 hrs after observing all the formalities issuing memo of arrest.

Under the above circumstances I, therefore, pray that a specific case u/s 46 (A)(c) of The Bengal Excise Act may kindly be registered against said Sudan Kumar (34 yrs) S/O Lt. Tulshi Kumar of vill- Uparkahan, P.S.- Joypur, Dist-Purulia under proper section of law.
