Sub: To lodge FIR against owner and driver of one Mahindra DI tractor having No. WB55B/6207 along with trolley (sand approx 60 CFT).

Sir,

In producing herewith, 01 (one) Mahindra DI tractor having No. WB55B/6207 along with trolley (loaded with sand approx 60 CFT). Today on 23.05.23 at about 06.35 hrs. during night mobile duty acting on source information, I SI Subal Goswami of Arsha PS along with (i) C/-924 Aswini Kr. Pandey of Arsha P.S and (ii) C/326 Prabin Kumar of SAP 7<sup>th</sup> BN camp at Arsha PS, Dist-Purulia, left for PS area vide C.C No. 1307/23 & GDE No. 966 Dtd. 22.05.2023. After we reached at Briddhitnr sand ghat, under Arsha PS at 07.15 hrs, we conducted raid on the Bank of Briddhitnr Ghat on the Bank of River Kansai under Arsha PS and found that 01 (one) tractor along with trolley attached with by a hinge was present at Beiddhitnr bridge Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Briddhitnr, fled away. Police rushed to the tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending tractor. Hence, I seized the above noted tractor along with trolley and brought the tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley for investigation.
