Sub: To lodge FIR against owners and drivers of 04(four) tractors (i) Mahindra YUVO 415 DI having Reg. No. WB55B/4260, Engine No. MBNSFAVEBLNE00409, Chassis No. NLE5FAE0101, (ii) Reg. No. WB55A/3372 (iii) Reg. No. WB55A/4544, Engine No. RFNE02766, Chassis No. RFNE02766 (iv) Reg. No. WB55A/ 9110, Engine No. E3443417, Chassis No. TO5533944370G, along with trolleys loaded with sand (approx 60 CFT of each trolley).

In producing herewith, 04 (four) tractors viz; (i) Mahindra YUVO 415 DI having Reg. No. WB55B/4260 (ii) Reg. No. WB55A/3372 (iii) Reg. No. WB55A/4544, Engine No. RFNE02766, Chassis No. RFNE02766 (iv) Reg. No. WB55A/ 9110, Engine No. E3443417, Chassis No. TO5533944370G, along with trolleys loaded with sand (approx 60 CFT of each trolley). Today on 28.05.23 at about 04.55 hrs. during night mobile duty, acting on source information, I SI Uttam Kr. Mandal of Arsha PS along with (i) C/-Dipak Bagti of Arsha P.S and (ii) C/Amit Manna of SAP 7<sup>th</sup> BN camp at Arsha PS, Dist-Purulia, left for PS area vide C.C No. 1341/23 & GDE No. 1143 Dtd. 27.05.2023. After we reached at Briddhitranr village, under Arsha PS at 05.15 hrs, we conducted raid on the Bank of Briddhitranr sand ghat on the Bank of River Kansai under Arsha PS and found that 04 (four) tractors along with trolley attached with by a hinge was present at Briddhitranr Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolleys of said tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolleys) at Briddhitranr Ghat, fled away. Police rushed to the tractors and detained the said tractors. Police searched the said tractors and found that the tractors is loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending tractors. Hence, I seized the above noted tractors along with trolleys and brought the tractors to Arsha PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted tractors along with the trolleys for investigation.
