On 11/05/2023 at about 11:50 a.m. I Sri Swapam Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Sajal Kumar Mahanty, Sr OE, Bagmundi CCC 2. Abdul Hasib, ACM, Bagmundi CCC, entered the premises of Sri Uttar Chandra Kumar, S/O- Late Sadananda Kumar of Village Torang, P.O.- Dava-Torang, PS- Bagmundi, Dist- Purulia and found Sri Uttar Chandra Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Uttar Chandra Kumar S/O- Late Sadananda Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sajal Kumar Mahanty, Sr OE, Bagmundi CCC 2. Abdul Hasib, ACM, Bagmundi CCC,. The inspection team left the premises at 11:55 a.m. on dated 11/05/2023.
