On 11/05/2023 at about 12:25 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Sajal Kumar Mahanty, Sr OE, Bagmundi CCC 2. Abdul Hasib, ACM, Bagmundi CCC, entered the premises of Sri Parikshit Garai, S/O- Late Mangal Garai of Village Kushaldih, P.O.- Kushaldih, PS- Bagmundi, Dist- Purulia and found Sri Parikshit Garai was enjoying electricity unauthorizedly drawing power from the nearest L&MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Parikshit Garai S/O- Late Mangal Garai committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sajal Kumar Mahanty, Sr OE, Bagmundi CCC 2. Abdul Hasib, ACM, Bagmundi CCC,. The inspection team left the premises at 12:35 a.m. on dated 11/05/2023.
