Sir,

In producing herewith the one accused person namely Robin Mahato (29 Yrs), S/O-Sadhu Charan Mahato of Vill-Ghorabandha, PS-Baghmundi, Dist.- Purulia along with seized articles (1) One white plastic jericin containing approx 08 (Eight) liter of ID Liquor, (2) 10 (Ten) pieces plastic glasses, (3) 500 ml I.D liquor from Sl No. 1 as sample which were seized under proper seizure list duly signed by the witnesses.

I beg to submit that today on 12.05.2023 during my mobile duty as per Baghmundi PS C.C No- 1080 & Baghmundi PS GDE No-546, Dtd: 12.05.2023 received source information that one selling ID liquor in his house premises without any valid documents. Accordingly, I SI Sudhir Kumar Mahato along with force (1) C/05 Biswajit Mahapatra (2) C/292 Raghunath Mahanta (3) C/66 Joydev Das & (4) C/2666 Patit Kumar Mondal of Baghmundi PS, Dist-Purulia reached at Ghorabandha village at about 16:45 hrs and found that the above noted person is selling I.D liquor in his house premises. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of ID liquor. In between 17:05 hrs to 17:15 hrs I seized (1) One white plastic jericin containing approx 08 (Eight) liter of ID Liquor, (2) 10 (Ten) pieces plastic glasses, (3) 500 ml I.D liquor from Sl No. 1 as sample from his possession U/S- 67 B.E Act which were seized under proper seizure list duly signed by the witnesses. All seized articles were labeled properly in presences of witnesses and accused person. Hence I arrested the above noted person at 17:25 hrs after maintaining all formalities and guidelines regarding arrest. I offered him for medical treatment but he refused.

The above noted arrested accused person namely Robin Mahato (29 Yrs), S/O-Sadhu Charan Mahato of Vill-Ghorabandha, PS-Baghmundi, Dist-Purulia committed an offence U/S- 46 (A) (c) B.E Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances, I therefore pray before you a specific case may kindly be started against the above noted accused person under proper section of law and arrange its investigation.
