I, Gurpreet Singh, Age - 31 years
S/o - Jagir Singh 37, Kunwar Basti, Old Purulia Road,
Ashoka Tower, Mango, P.O. - Mango, Jamshedpur,
East Singhbhum 831012 beg to state that on
01.05.2023 myself along with my mother namely Dalbir Kour
was coming from Dhanbad to Jamshedpur by
riding my motorcycle ride bearing No. JH-10M-1177
(JH-10M-1177) via Balrampur through Purulia
Tata Main road. At about 11:30 A.M. when we
were crossing the Balrampur Bypass road
through NH-32 under Balrampur Police Station,
District - Purulia, at that time one tractor
coming from backside, dashed my
motorcycle and the said tractor
ran over my mother's leg. As a result
my mother's left leg has been
completely damaged and she received
serious bleeding injury. With the help of
local Public my mother was shifted to
local hospital and the doctor referred
her for better treatment to TMH Jamshedpur.
My motorcycle also got damaged due to
the accident.
