Place of Crime: The crime is committed at our residential property situated at R.S.Plot No.-2655 (7 decimal), R.S.Plot No. RS-2656 (20 decimal), under Rangadih Mouza, Block & P.S.: Balarampur, District: Purulia.

Sir,

On 15.05.2023 at around 1:20 am at midnight, the above named accused knocked the door of our residential property (address given above as the place of crime), while my father Shri Pradip Banerjee, aged about 68 years, and my mother Smt. Sanchita Banerjee, aged about 66 years, are residing inside the house. My father opened the door and Badal Gorai forcefully entered into our house following all other above named accused, and severely beaten my parents with dangerous weapons or means, and left the house leaving them in a deadly condition, with a direction to leave Balarampur by early morning evacuating the property, otherwise next morning they will set ablaze the house. They severely damaged the mud tiled roof of the old property, snatched gold ornaments which my parents were wearing, including mobile phones and cash, which in total worth around 4 Lakh rupees, and thereby committed robbery.

While going out from our residence, they broke the boundary of our residence by using bulldozer and digged some portion of our land following the site boundary, and thereby severely damaged our residential property. The bulldozer/excavator belongs to Ganesh or Kartik Gorai.

The intension of the abovenamed accused are to take physical possession of the land and property at Plot No. 2655, 2656, by extorting the victims and by applying criminal force, causing grievous hurt and to do anything which is illegal and which facilitate the commission of the offence.


Both of my ailing aged parents received multiple injury in spine, head, and whole body, and in a critical condition.

On 15th morning, after such incident, the victims were evacuated to their Kolkata residence and now under treatment.

Such an activity is punishable under Section 307, 329, 394, of Indian Penal Code and therefore requesting you to lodge a complaint against the accused abovenamed, seize the vehicle/bulldozer/excavator used in the crime, and arrest the accused with immediate effect in order to protect the life and property of the abovenamed victims.

May this be noted that the victims are a reputed person of the Village Balarampur, the Government Nominee Member of the Governing Body of Balarampur College, and a responsible citizen, who are passing their old ages and remaining days in peace, while the above named accused are habitual offender and several criminal cases are registered under this P.S. against the accused abovenamed.
