Respected Sir,

In producing herewith accused person namely Bisnupada Gorai (28), s/o Lt. Buddheswar Gorai of Village- Gangamanna, PS- Bandwan, Dist- Purulia with the seized articles i.e. (i) **Approx 10 Litters Illicit Distil liquor in a 10 Litters white jericen marked as Exhibit "A (ii) 01 Litter Illicit Distil liquor taken from Exhibit "A" in a bottle as sample marked as Exhibit "A-1"**. I beg to submit that on 09/05/2023 at about 16.05 hrs. I received a credible source information while I was engaged in Mobile duty that one person namely Bisnupada Gorai (28), s/o Lt. Buddheswar Gorai of Village- Gangamanna, PS- Bandwan, Dist- Purulia is stocking and selling Illicit Distill liquor without any valid license from his back side of dwelling house at Village- Gangamanna, PS- Bandwan, Dist- Purulia. Accordingly, I along with C/788 Rabindra Nath Baidya & C/340 Baman Das Goswami all of Bandwan P.S., Dist-Purulia vide Bandwan P.S. M.C.C. No. 1739/23 Dtd: 09/05/2023 left for Gangamanna village to work out the said source information and held raid at the back side of his dwelling house where the above mentioned accused person stocking and selling Illicit liquor. During search with the help of accompany force, we found that the said person is stocking Illicit Distill liquor for sell. Being asked, he disclosed that all liquor has been stocked for the purpose of sell. On demand, he failed to produce any valid documents/ License in respect of stocking and selling of Illicit Distill liquor. Accordingly, I seized all the Illicit Distill liquor (details in attached seizure list) in between 16.45 hrs to 17.25 hrs after preparing proper seizure list duly signed by the witnesses. One litter Illicit Distill liquor has been kept & labelled as sample bottle marked as Exhibit "A-I. Approx 10 litters Illicit Distill liquor has been seized marked as Exhibit "A. Then, I arrest him at 17.25 hrs. After maintaining all legal procedures regarding arrest as laid down by Hon'ble Supreme Court after preparing proper arrest memo as he committed offence U/S- 46A (C) B.E. Act 1909 and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) B.E. Act 1909 against the arrested accused person namely Bisnupada Gorai (28), s/o Lt. Buddheswar Gorai of Village- Gangamanna, PS- Bandwan, Dist- Purulia and arrange for its investigation.
