Sub: Complaint against Amrit Ruhidas (36 Yrs) S/o- Lt Biswanath Ruhidas of Vill+P.O- Sukurhutu, PS- Barabazar, Dist- Purulia to start a specific case as per law.

Sir,

In producing here with one arrested accused namely Amrit Ruhidas (36 Yrs) S/o- Lt Biswanath Ruhidas of Vill+P.O- Sukurhutu, PS- Barabazar, Dist- Purulia and seized articles one white colour Plastic Jerican containing approx 09 (Nine) Ltrs of I.D liquor(Cholai), on which 500 ml seized as sample under proper seizure list.

I, ASI Manas Kr. Pan of Barabazar PS do here by lodge this complaint against Amrit Ruhidas (36 Yrs) S/o- Lt Biswanath Ruhidas of Vill+P.O- Sukurhutu, PS- Barabazar, Dist- Purulia that on today i.e. 09.05.2023 received a source information that one person unauthorized keeping & selling I.D liquor in his house at Sukurhutu village under Barabazar PS. I have been then verified the credibility of that information and immediately informed to my I.C. As per direction of I.C Barabazar PS myself contact with PS evening mobile duty officer and left for Sukurhutu village at about 18:05 hrs arrived in the house of the alleged person to work out the information with mobile duty party. Seeing the Police party, customers fled away. Somehow we apprehended one. On being asked he disclosed his identity as above and confessed that he keeping & selling ID liquors without any valid documents with intent to make own profit. On searching we found one white colour plastic jarican containing approx 09 (Nine) Ltrs. ID Liquor (Cholai) from his house. Accordingly, I seized the same under proper seizure list duly signed by the said alleged person & witnesses then I take 500 ml from mother contraband as sample and put label on both seized article. Thereafter, I arrest the accused person namely Amrit Ruhidas (36 Yrs) S/o- Lt Biswanath Ruhidas of Vill+P.O- Sukurhutu, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all formalities regarding arrest as per Cr.PC and NHRC guide line. Informed him and his relatives regarding the ground of arrest. The arrest was made at 18:45 hrs.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered as per law against said Amrit Ruhidas (36 Yrs) S/o- Lt Biswanath Ruhidas of Vill+P.O- Sukurhutu, PS- Barabazar, Dist- Purulia and also arrange for its investigation.
