Sub: Complaint against (i) Nehal Gope (22 Yrs) S/o- Lt. Sudhir Gope and (ii) Bhaku Singh Sardar S/o- Lt. Badal Singh Sardar both of Village- Pattoria, P.O- Dhadkidih PS- Barabazar, Dist- Purulia to start a specific case as per law.

Sir,

In producing here with two arrested accused persons namely (i) Nehal Gope (22 Yrs) S/o- Lt. Sudhir Gope and (ii) Bhaku Singh Sardar (27 Yrs) S/o- Lt. Badal Singh Sardar both of Village- Pattoria, P.O- Dhadkidih PS- Barabazar, Dist- Purulia and seized articles one white colour Plastic Jerican containing approx 19 (Nineteen) Ltrs of I.D liquor (Cholai), on which 500 ml seized as sample under proper seizure list.

I, ASI Jaydip Mukherjee of Barabazar PS do here by lodge this complaint against the above noted persons to the effect that on 17.05.2023 at 18.05 hrs during my mobile duty received source information that above noted person unauthorized keeping & selling I.D liquor (Cholai) at Pattoria Sardarpura Battola under Barabazar PS. I have then verified the credibility of that information and immediately informed to my I.C. As per direction of I.C Barabazar PS myself along with force had been to the spot to work out the information. Seeing the Police party, customers fled away. Somehow we apprehended the sellers, On being asked they disclosed their identity as noted above and confessed that they are keeping & selling ID. liquors (Cholai) without any valid documents with intent to make their own profit. On searching we found one white colour plastic jarican containing approx 19 (Nineteen) Ltrs. ID Liquor (Cholai) from that place. Accordingly, I seized the same under proper seizure list in between 18.55 hrs to 19.15 hrs duly signed by the said alleged persons & witnesses then I took 500 ml from mother contraband as sample and put label on both seized articles. Thereafter, I arrested the accused persons namely (i) Nehal Gope (22 Yrs) S/o- Lt. Sudhir Gope and (ii) Bhaku Singh Sardar (27 Yrs) S/o- Lt. Badal Singh Sardar both of Village- Pattoria, P.O- Dhadkidih PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all formalities regarding arrest as per Cr.PC and NHRC guide line, informed them and their relatives regarding the ground of arrest. The arrest was made at 19.25 hrs.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered as per law against the above noted accused persons namely (i) Nehal Gope (22 Yrs) S/o- Lt. Sudhir Gope and (ii) Bhaku Singh Sardar (27 Yrs) S/o- Lt. Badal Singh Sardar both of Village- Pattoria, P.O- Dhadkidih PS- Barabazar, Dist- Purulia and also arrange for its investigation.
