Sub: Complaint against Sahadeb Gope (26 yrs) S/o Sukumar Gope of Vill-Barrah, PS- Barabazar, Dist- Purulia to start a specific case as per law.

Sir,
In producing here with arrested accused person namely Sahadeb Gope (26 yrs) S/o Sukumar Gope of Vill-Barrah, PS- Barabazar, Dist- Purulia and seized articles one white colour Plastic Jerican containing approx 09 (Nine) Ltrs of I.D liquor (Cholai), in which 500 ml seized as sample under proper seizure list and Memo of arrest.

I, ASI Tarun Kumar Bhui of Barabazar PS do here by lodge this complaint against the above noted persons to the effect that on 30.05.2023 at 17:15 hrs during my raid duty received source information that above noted person unauthorizedly keeping & selling I.D liquor (Cholai) at Barrah village under Barabazar PS. I have then verified the credibility of that information and immediately informed to my I.C. As per direction of I.C Barabazar PS myself along with force had been to the spot at 17:25 hrs to work out the information. Seeing the Police party, customers fled away. Somehow we apprehended the seller, On being asked he disclosed his identity as noted above and confessed that he is keeping & selling ID liquors (Cholai) without any valid documents with intent to make his own profit. On searching we found one white colour plastic jarican containing approx 09 (Nine) Ltrs. ID Liquor (Cholai) from that place. Accordingly, I seized the same under proper seizure list in between 17:35 hrs to 17:45 hrs duly signed by the said alleged person & witnesses then I took 500 ml from mother contraband as sample and put label on both seized articles. Thereafter, I arrested the accused person namely Sahadeb Gope (26 yrs) S/o Sukumar Gope of Vill-Barrah, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all formalities regarding arrest as per Cr.PC and NHRC guide line, informed him and hisrelatives regarding the ground of arrest. The arrest was made at 17:45 hrs.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered as per law against the above noted accused person namely Sahadeb Gope (26 yrs) S/o Sukumar Gope of Vill-Barrah, PS- Barabazar, Dist- Purulia and also arrange for its investigation.
