The humble petition on behalf of the complainant.

Most respectfully sheweth:-

1. That your ~~ex~~ complainant and the accused persons are all resident of Vill. Sijumakhna, P.O. Dapang, P.S.- Hura, Dist. Purulia, and within the jurisdiction of this court.
2. 

3. That on the date of occurance Nakul Mahato and Ashok Mahato uprooted eight mango plant of your complainant forcibly and allegedly and there after on 10.3.23 all the accused persons being armed with deadly weapons like lathi, tangi, kural etc. forming unlawful assembly with an intention to commit murder and also to damage the boundary and to grab some portion from R.S.Plot No.1708 of mouza sijumakhn of the complainant into their small pond (Hafa)forcibly and illegally enter into the land bearing R.S./L.R.Plot No.1708 of mouza Sijumakhna and they started to damage the boundary, amalgated the plot into their small pond all the accused persons to allowing many branches of three and stran kept by your complainant. All the accused persons abuse in various filthy language.

4. That complainant raise objection the illegal activities of the accused person then the accused persons became very angry and the assaulted the complainant by fist and blows on different part of the body of the complainant. That the complainant sustain loss of Rs.10,000/- (Ten thousand). The witnessess above named saw the occurance and the matter was also reported to them.
