Sub - FIR against the owner and driver of a tractor vehicle being no. WB 55 A 6280 and others in connection with illegal mining activities at Kayandi village near Sonaijhuvi jungle side latitude - 23.235339, Longitude - 86.590781, Altitude - 133.0 ±

Sir

This is to inform you that the office of the undersigned have conducted a joint raid along with the officials of your good office on 11/5/2023 at Kayandi village, near Sonaijhuvi jungle. During the raid it is observed that one tractor being no. WB 55 A 6280 was loading the sand minerals from the stack point at Kayandi village under the hura bluey. During the raid the driver of the tractor <sup>(app)</sup> ran away from the place of occurrence.

As there is no permission to stack the illegally extracted sand minerals and they load the stacked sand, so the undersigned seized the stack sand minerals along with a tractor being no. WB 55 A 6280 carrying with lot of sand minerals (approx) and hand over the same to the Hura PS for safe custody in presence of all officials.

Therefore the undersigned is requesting you to lodge an FIR under the Rule 33 of the W.B.M. Rules 2002 read with section 21(a) of the Mines and Minerals (Regulation and Development) Act, 1957, rule 5(1)(iv), W.B. (Prevent of illegal mining, Transportation and Storage).
