Sub: - Complaint against Joydeb Das (30 Yrs) S/O- Lt. Santosh Das of Vill- Rakhera, PS-Hura, Dist-Purulia to start a cog case U/S-46A(c) B.E. Act.

Sir,

In producing here with arrested accused namely Joydeb Das (30 Yrs) S/O- Lt. Santosh Das of Vill- Rakhera, PS- Hura, Dist- Purulia along with seized Country Spirit bottles DIL SE 10 (ten) bottles 600 ML each (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 12.05.23 while I SI Bablu Ghosh along with force namely C/1580 Alam Ansary, C/496 Prakash Ch. Mahato and C/1446 Alok Ranjan Lohar were performing evening mobile duty vide Hura PS GDE No- 547 dtd-12.05.2023 and C.C. No-1471/23 at about 19.35 hrs. received a credible information from my reliable source that the above noted accd. person was stoking and selling Country Spirit at Rakhera village in his hotel (Das Hotel). Accordingly I informed the matter to OC Hura and as per his instruction I SI Bablu Ghosh along with force left for work out that information. After reaching to spot at about 20.05 hrs. along with force and held raid in the hotel (Das Hotel) of above noted accd. at village Rakhera under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country sprit which was kept in his hotel at village Rakhera under Hura PS, Dist Purulia. On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. Accordingly, I seized total 10(ten) sealed Country Spirit bottles DIL SE 600 ML each after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle. As he committed offence u/s- 46A (C) B.E. Act. So I arrested him u/s- 67 B.E. Act. after preparing proper Arrest Memo, maintained all formalities regarding arrest and supplied one copy to him. Entire process completed in between 20.15 hrs. to 20.35 hrs. This is to note here that on seeing police party all public/customers fled away.

Under the above fact circumstances and, I therefore pray that a Cog. Case U/S 46A(c) B.E Act may kindly be started against the arrested accused person namely loydeb Das (30 Yrs) S/O- Lt. Santosh Das of Vill- Rakhera, PS- Hura, Dist- Purulia and arrange for its investigation.
