I, ASI Majibur Rahaman along with force return to PS and brought under seizure One Sir. tractor Bearing Registration No. WB55B/5616, Chassis no-MBNABAEXKMRH07819 & Engine no-RMH2EAN3912 styled as Mahindra attached with trolley loaded with sand (approx 100 cft). The fact in brief is that today (15/05/2023) I along with force namely i) C/2032-Sourav Roy ii) C/2323-Padma Lochan Karak and iii) C/3408-Rajkishor Kumar were performing Spl. mobile duty at Tulin OP under Jhalda PS area vide Tulin OP under Jhalda PS GDE No- 466 Dated- 15/05/2023 in consonance with Tulin OP under Jhalda PS CC No-1360/23 Dated- 15/05/2023. During my Spl. mobile duty I received a credible source information that one Tractor was lifting & carrying sand illegally and coming from Choupad village Side near Subarnarekha River & coming towards Jhalda side. Subsequently, I informed you and as per your order, I placed Naka at Near Choupad Village more to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one tractor was proceeding towards Choupad village side. Consequently, we intercepted the said Tractors at Naka checking point on 15/05/2023 at about 16:05 hrs. and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police, driver of Tractor fled away leaving the Tractor on road before Naka checking point. We tried to chase him but in vain. After that we searched the said Tractor for valid documents but did not find any valid documents in respect of loaded sand in the tractor. Hence I seized the Tractor Bearing Registration No. WB55B/5616, Chassis no-MBNABAEXKMRH07819 & Engine RMH2EAN3912 styled as Mahindra attached with trolley loaded with sand (approx 100 cft) under proper seizure list in presence of available witnesses duly signed by them. Thereafter I brought the said tractor to Jhalda P.S. As such there is every reason to believe that the driver and owner of the Tractor Bearing Registration No. WB55B/5616, Chassis no-MBNABAEXKMRH07819 & Engine no-RMH2EAN3912 styled as Mahindra fitted with Trolley with ill motive are transporting sand illegally without any valid document in support of carrying sand.

Therefore, I pray before you that a case against the driver and owner of Tractor Bearing Registration No. WB55B/5616, Chassis no-MBNABAEXKMRH07819 & Engine no-RMH2EAN3912 styled as Mahindra fitted with Trolley may kindly be started under proper section of law and arrange for its investigation.
