Respected Sir,

In producing here with 01(One) arrested accused person namely Chutubabu Kumar (35) S/O Lt Gopal Kumar of Vill- Chekya, PS- Kotshila, Dist- Purulia and along with seized 01(one) Tractor having Registration No- WB55B5375 attached with sand loaded trolley and sand is covered by a tarpaulin and a layer of laterite soil (sand approx 100 cft) . The fact in brief is that on (18/05/2023) I along with force namely (i) C/1492 Dilip Ch. Gorain (ii) C/2182 Md. Safiul Khan were performing day mobile duty in PS area vide Jhalda P.S. GDE No- 894 Dated- 18/05/2023 in consonance with Jhalda PS CC No- 1738/23 Dated- 18/05/2023. During my day mobile duty, I received credible source information that one Tractor was lifting & carrying sand illegally from Basudih Ghat and sand is covered by tarpaulin and a layer of laterite soil to circumvent the police and other authority and coming from Jargo side towards Jhalda Town. Subsequently, I informed you and as per your gracious order, I placed Naka at on Jhalda Bagmundi pitch road at Birudih more to work out this tip off and started Naka Checking after proper placing guard rail on Jhalda Bagmundi pitch road at Birudih more. Thereafter I saw the one Tractor was proceeding towards Birudih more. Consequently, we intercepted the said Tractor at before Naka checking point at about 12:35 hrs and found that the vehicle and the goods as identical as I received prior information. But seeing the Police Party driver who was on that vehicle (Tractor) started to flee away. After hot chase we managed to apprehend him. On being asked, the driver of the vehicle disclose his identity noted in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the sand loaded trolley. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand loaded trolley. I also asked the driver of the vehicle about sand covered by tarpaulin and a layer of laterite soil and driver of the vehicle said that the sand is covered by tarpaulin and a layer of laterite soil to circumvent the Police and Mines department. I repeatedly asked the driver to produce the valid papers but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the driver of the Tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. They started a process to circumvent the police and mines department by using the tarpaulin as well as a layer of laterite. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Subarnarekha River from Basudih Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business in a habitual manner. Ergo I, seized the Tractor having Registration No- WB55B5375 attached with sand loaded trolley and sand is covered by tarpaulin and a layer of laterite soil (sand approx 100 cft) under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Chutubabu Kumar (35) S/O Lt Gopal Kumar of Vill- Chekya, PS- Kotshila, Dist- Purulia after informing the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said Tractor to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the driver namely Chutubabu Kumar (35) S/O Lt Gopal Kumar of Vill- Chekya, PS- Kotshila, Dist- Purulia and the Owner of the said vehicle as they committed an offence U/S 379/411/413/414/120B of the IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.
