Sir,

In producing here with arrested accused persons namely 1) Prasanjit Kumar (22) S/O Karam Kumar of Vill- Durgu, PS-Kotshila, Dist-Purulia , 2) Nawab Haider (25) S/O Nasim Haider of Vill-Katinpara, PO-Ketka, PS-Purulia (T), Dist-Purulia 3) Md. Taj (28) S/O Md. Ahammad Hussain@ Adman of Vill- Tulin,PS-Jhalda,Dist- Purulia and seized articles (i)One Bhujali attached with steel handle total length approx 1.3 ft and sharp edge of Bhujali is approx. 09 inches (ii) One iron saw attached with wooden handle length approx 1.6 ft and sharp edge of saw is approx. 12 inches (iii) One nylon rope in white colour length approx 18 mtr (iv) One Bhujali attached with wooden handle length approx 1.4 ft and sharp edge of Bhujali is approx. 11 inches (v) One Iron Rod length approx 3 ft (vi) One sword attached with wooden handle total length approx 2.2 ft and sharp edge of sword is approx. 1.8 ft (vii) One bundle of cello tap in brown colour (viii) One Bamboo stick length approx 3.5 ft (ix) One Bamboo stick length approx 3.4 ft lodged complain against them and 08/09 others to the effect that on 19/05/2023 at about 23.35 Hrs during Spl. evening mobile duty, I was performing W/A raid duty at Maru village area. During holding raid, I received a credible tip that a gang of dacoits being armed with deadly weapons assembled under Kau tree near Khijria bandh situated at Gokulnagar and they were preparing themselves for committing dacoity of a house of a teacher at Jhalda Town. Subsequently I, informed to you as well as the Duty Officer and as per your direction I asked the duty officer to note the information down in the GDE Vide Jhalda PS GDE No 988 Dated 19/05/2023. On getting the tip off as per kind order myself accompanied with force who were detailed for the Spl. evening mobile Duty with me namely (i) C/441 Santo Das (ii) C/1492 Dilip Ch. Gorain (iii) C/331- Mansaram Kumar (iv) C/955-Dilip Kr. Mandal all of Jhalda PS vide CC No. 1762/23 dated 19/05/2023 & vide Jhalda PS GDE NO 967 Dated 19/05/2023 immediately proceeded to the anticipated place of assemble to work out the information and reached near Mahato hotel at 00:05 Hrs on 20.05.2023 leaving the Police vehicle No- WB 56N4121 there and started to proceed for the anticipated place on foot. At 00:15 Hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that 11/12 persons assembled under Kau tree near Khijria bandh approx 80 mtr away from Jhalda Bagmundi road situated at Gokulnagar and those persons are whispering themselves from which it was clear that they are preparing themselves to

commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up only 03 (three) of them while the rest 08/09 had managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to search them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered the following articles from the exclusive possession of the respective accused person (i) One Bhujali attached with steel handle length approx 1.3 ft and sharp edge of Bhujali is approx. 09 inches (ii) One iron saw attached with wooden handle length approx 1.6 ft and sharp edge of saw is approx. 12 inches (iii) one lylon rope in white colour length approx 18 mtr from the possession of Prasanjit Kumar, (i) One Bhujali attached with wooden handle length approx 1.4 ft and sharp edge of Bhujali is approx. 11 inches (ii) One Iron Rod length approx 3 ft from the possession of Nawab Haider (i) One sword attached with wooden handle length approx 2.2 ft and sharp edge of sword is approx. 1.8ft (ii) one cello tap in brown colour from the possession of Md Taj, I also search the PO and found that (i) One Bambo stick length approx 3.5 ft (ii) One Bambo stick length approx 3.4 ft. Subsequently, I seized all the following articles recovered from their exclusive possession in between 00:45 hrs to 01:15 hrs on 20/05/2023 from the place of assemble of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities, (i) One Bhujali attached with steel handle length approx 1.3 ft and sharp edge of Bhujali is approx. 09 inches (ii) One iron saw attached with wooden handle length approx 1.6 ft and sharp edge of saw is approx. 12 inches (iii) one lylon rope in white colour length approx 18 mtr (iv) One Bhujali attached with wooden handle length approx 1.4 ft and sharp edge of Bhujali is approx. 11 inches (v) One Iron Rod length approx 3 ft (vi) One sword attached with wooden handle length approx 2.2 ft and sharp edge of sword is approx. 1.8ft (vii) one cello tap in brown colour (viii) One Bambo stick length approx 3.5 ft (ix) One Bambo stick length approx 3.4 ft from the place of assembly under proper seizure list as well as labelled duly signed by apprehended persons and witnesses as Alamat. On interrogation they confessed their guilt and they also stated that they have assembled there with 08/09 others, 1) Bhalka 2) Imroj both of Vill-Kantadih, 3) Sk. Jamil of Vill- Hussaindih, PS- Jhalda, Dist- Purulia were among them for committing a house dacoity of a teacher's house at Jhalda Town. I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place, so I could not able to accompany with public witness. Under such circumstances it is reasonable to believe that the above

noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested those persons after preparing memo of arrest and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Prasanjit Kumar (22) S/O Karam Kumar of Vill- Durgu, PS-Kotshila, Dist-Purulia, 2) Nawab Haider (25) S/O Nasim Haider of Vill- Katinpara, PO-Ketka, PS-Purulia (T), Dist-Purulia 3) Md. Taj (28) S/O Md. Ahammad Hussain@ Adman of Vill- Tulin, PS-Jhalda, Dist- Purulia along with 1) Bhalka 2) Imroj both of Vill-Kantadih, 3) Sk. Jamil of Vill- Hussaindih, PS- Jhalda, Dist- Purulia who fled away from the spot along with 05/06 others under proper section of law.
