Sub-: Request for register a F.I.R against Chaya Lohar (Karmakar) for mishandling of pet dog causing dog bite to my teenage son.

Sir,

I, Raja Sen, of Namo Para, Ward No: X, Jhalda Municipality would like to inform you that on last Thursday i.e. 18/05/2023 at about 6.45 am my son namely Sannidhya Sen aged about 15 years was retuning back from morning walk, when the pet dog (probably German Shepherd breed) of Chhaya Lohar (Karmakar) (D/o. Hari Lohar) bit him at multiple spots very aggressively. The dog was in the hands of Mr. Mahabir Lohar (brother of Chhaya Lohar) and he was busy in operating his mobile phone the dog was left out casually as a result of which it bit my son. He became senseless due to the injury & fear and was rescued by the public in the nearby area or else he might have been injured even more seriously.

Moreover, my son is under medical treatment at present, a copy of the Doctor's prescription is attached herewith for your ready reference. Please note that my son is in state of pain, mental trauma & fear due to such incidence and for this reason, I went to Mrs. Lohar and requested her to hand over the dog to some animal care center to avoid any such incidence in future. However, upon my request she and her brother (Mahabir Lohar) started yelling and shouting at me saying that they will not leave the dog at any condition and also threatened me hurt me.

Please note, that previously the same dog has bit two persons namely i) Rakesh Chalak, S/o. Sukra Chalak of Kumar Para, Ward No- 6, Jhalda Municipality and ii) Gopal Sadhu Machwar, S/o. Late Mahadeb Machwar of POka Bandh Para, Ward No: VI, Jhalda Municipality. The medical prescription of Mr. Gopa Sadhu Machwar is attached herewith.

As such, it is my humble request to lodge a FIR against Mrs. Chhaya Lohar and her brother Mr. Mahabir Lohar for such mishandling of pet dog and for threatening me, as well as to take needful action against her as per prevailing law.

I hope you will extend your kind co-operation in this regard.
