Subj: Complain About Physical Assault

Respected Sir,

I, Bindu Hite, student of Ramkrishna Mahato Govt, Engineering college, Purulia of 3rd Year ECE, c/o Shibu Hite from Singur, Hoogly, got attacked by Ranadeep Mondal (CE, 3rd Year), Prosenjit Kumar (CE, 3rd Year) and Irfan Habib (EE, 3rd Year). Ranadeep Mondal assaulted me by his steel bangal on my left eye. Prosenjit Kumar pulled my neck and teared my t-shirt. Irfan Habib continuously beating me on my back head. They aboned me also. This incident happened on 29.04.23 night likely about 12:30 Am. My batchmate Niraj Kr. Barnwal (EE, 3rd Year) also assaulted by Jugantar Chakrabarty (ESE, 3rd Year). Jugantar Chakrabarty pushed Niraj Kr. Barnwal on the grill of window. Niraj got injured on his neck and head so heavily that he felt unconscious and got admitted to the hospital. His left leg ~~was~~ was injured also and bled so much. I attached the hospital reports.

I requesting you kindly look into this matters. cause the convicts were giving us the murders threat. I will be highly obliged if you take legal action against them, so that my life risk get assured. Thanking you.
