Sir,

In producing herewith one arrested accused person namely Smt. Debi Kaibarta (35 yrs) D/o- Lila Kaibarta of Joypur Kaibarta PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (1) 60 (Sixty) bottles India Made Liquor styled as "DIL KUSH" strength measuring 600 ML each bottle (2) 20 (Twenty) bottles India Made Liquor styled as "DILSE" strength measuring 600 ML each bottle, out of which two bottles taken as sample under proper seizure with label.

I, LSI Sumana Kar of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (02/05/2023) at about 15:25 hrs when myself along with C/-1177 Samir Ch. Das, C/-1387 Prabir Kr Mishra, C/-1434 Jagannath Mandal, LC/-3065 Sangita Banerjee were performing Evening Mobile duty vide Joypur PS C.C. No-864/23 date-02/05/2023, as per my source information I reached at Joypur Atakol more in the Shop of Smt. Debi Kaibarta under Joypur PS and found that the above noted accused person was selling Indian made liquor "DILSE" & "DIL KHUSH" in her shop. On seeing Police persons, she concealed her presence inside the shop, but on searching we able to trace out her and also found a total number of 80 (eighty) bottles of India made liquor "DILSE" & "DIL KHUSH" which were kept concealed inside the shop. On being asked she disclosed her name and address as noted above. On interrogation she stated that she was selling India Made Liquor to the local people in Joypur Bazar area after procuring from other side, but on demand she failed to produce any valid documents in respect of selling such country spirit. So, it is reasonable to believe that she was selling the Id liquor illegally without any valid documents. So, I seized the same under proper seizure list in between 16:35 hrs to 16:55 hrs & labeled those, duly signed by her and other available witness after taking 01 bottle "DILSE" & 01 bottle DIL KUSH as sample out of 60 (Sixty) bottle of DIL KHUSH each bottle 600 ML & 20 (Twenty) bottle DILSE each bottle 600 ML.

During further interrogation she confessed her guilt subsequently, I arrested her abiding by all the guidelines of the Apex Court on today (02/05/2023) at 17:15 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Smt. Debi Kaibarta (35 yrs) D/o- Lila Kaibarta of Joypur Kaibarta PS-Joypur, Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909.
