In producing herewith seized 02 (two) Tractors bearing Registration No (1) JH02BE-9242 (Red colour Mahendra B-275DI) along with trolly (2) WB55-3843 (Red colour Mahendra B-275DI) along with trolly each Tractors loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (17/05/2023) I, ASI Tarapada Hazari along with force (1) C/-858 Chepulal Murmu (2) C/-1358 Sanjib Patra (3) NVF/-1021 Bablu Mahato all of Joypur P.S were performing Day Mobile duty vide Joypur PS CC No-1018/23 Date-17/05/2023. During my mobile duty at about 14:45 hrs received a credible source information that two Tractors loaded with sand is coming from Chas Road side towards Jharkhand. I along with force when reached near Krishna Line Hotel at Bartard on NH-32 under Joypur PS and found that 02 (two) Tractors bearing Registration No (1) JH02BE-9242 (Red colour Mahendra B-275DI) along with trolly (2) WB55-3843 (Red colour Mahendra B-275DI) along with trolly each Tractors loaded with sand (100 CFT approx) were coming. On seeing the Police party near Krishna Line Hotel at Bartard on NH-32 under Joypur PS, the drivers of the both Tractors fled away leaving the tractors standing beside the road. We rushed to the Tractors and searched the both Tractor and also searched surrounding the P.O but I did not trace out the drivers / owners of the said Tractors. Hence, I seized the 02 Tractors bearing Registration No (1) JH02BE-9242 (Red colour Mahendra B-275DI) along with trolly (2) WB55-3843 (Red colour Mahendra B-275DI) along with trolly each Tractors loaded with sand (100 CFT approx) under proper seizure list in between 15:05 hrs and 15:45 hrs in presence of available witnesses and I brought the said Tractors to Joypur P.S. As such there is every reason to believe that the **drivers** and **owners** of the said both Tractors are dealing with sand illegally and transporting with ill motive without any valid document.

Hence, the drivers and owners of the both tractors are liable for offence punishable U/S-379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of the both Tractors may kindly be started and arrange for its investigation.
