In producing herewith the red coloured Mahindra Tractor bearing Engine No- RLL2EAN0337, Chassis No – MBNABAEXKLRL01997 attached with Trolley without number plate loaded with sand approx. 100 cft.

The fact of the case in brief is that on 01.05.2023 I along with C/819 Ujjal Mahato and C/870 Arup Karmakar both of Kenda PS were performing night mobile duty vide Kenda PS CC No.552 Dated 30.04.2023. During night mobile duty on 01/05/2023 at about 05:35 hrs I, received source information that some persons are lifted sand from Sitapanj area of Kansai riverbed near Konapara village under Kenda PS by illegal means. Then I informed the matter to O/C Kenda PS and as per order of O/C Kenda PS left to work out the information and at about 05:55 hrs when we reached at Sitapanj area of Kangsabati/Kansai riverbed near Konapara village found that the above noted tractor was being loaded by some persons. Seeing the Police party driver of the said vehicle and other persons fled away from their leaving the vehicle (Tractor). We chased them but could not apprehend. We stay bearing Engine No- RLL2EAN0337, Chassis No – MBNABAEXKLRL01997 attached with Trolley without number plate loaded with sand approx. 100 cft. there for some time to identified the owner of the said tractor and also the driver of the said tractor. But nobody came forward at that time. So, there is every reason to believe that the sand was lifted there by those persons in an illegal way. So, I seized red coloured Mahindra Tractor bearing Engine No- RLL2EAN0337, Chassis No – MBNABAEXKLRL01997 attached with Trolley without number plate loaded with sand approx. 100 cft under preparing proper seizure list duly signed by the available witnesses. Thereafter arranged driver from my source and brought the tractor at Kenda PS. So, there have sufficient reason to believe that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above the fact and circumstances kindly take lawful action against driver and owner of the tractor bearing Engine No- RLL2EAN0337, Chassis No – MBNABAEXKLRL01997 attached with Trolley without number plate loaded with sand approx. 100 cft.
