Sub: Complaint against Falguni Mahato (45 yrs) S/O-Lt Mahindi Mahato of Vill-Hetbatri, PS-Kotshila, Dist-Purulia to start a case U/S-46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. Falguni Mahato (45 yrs) S/O-Lt Mahindi Mahato of Vill-Hetbatri, PS- Kotshila, Dist-Purulia with seizure of approx 12 (Twelve) liters illicit liquor (Cholai) from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (04.05.2023) during SpI mobile duty acting on secret source information, I held raid at 19:25 hrs in the house of above noted person at Hetbatri village who stocked illicit spirit in his house. I searched the place and found approx 12 (Twelve) Liters illicit spirit which was kept in a white colour Jaricane. On interrogation, he disclosed his name and address as noted above and also stated that he sells the same for his gain in lieu of money. On demand he failed to produce any valid documents in respect of illicit spirit which was kept in his house. Accordingly I seized the same under proper seizure list in between 19:30 hrs to 19:45 hrs in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 19:45 hrs U/S- 67 B.E. Act and during arrest, the ground of arrest was duly notified issuing arrest memo U/S- 50 Cr. P.C. and handed over a copy of the same to the arrestee. Out of seized illicit liquor 500 (Five Hundred) ml. was taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Falguni Mahato (45 yrs) S/O-Lt Mahindi Mahato of Vill-Hetbatri, PS- Kotshila, Dist-Purulia violated the provision of section 18 (i) B.E. Act. for possessing and selling of illicit spirit without obtaining license from a licensing vendor and in contravention, he Committed an offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid C/332 Ashok Kr Kandu & C/2242 Dinesh Ch Kar accompanied me Vide Kotshila P.S C.C No 419/2023, Dated 04.05.2023.

Under the fact and circumstance I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against the arrested accd person namely Falguni Mahato (45 yrs) S/O-Lt Mahindi Mahato of Vill-Hetbatri, PS- Kotshila, Dist-Purulia.
