Sir,

In producing herewith 03(Three) seized Tractors fitted with Trolley loaded sand (Approx 100 CFT & 50 CFT) 1. One Tractor (Blue Color 380 Eicher) having Registration No WB55A/8366 fitted with trolley loaded sand approx 100 Cft 2. One Tractor (Red Color 415 DI Dlx Mahindra) having Registration No WB55B/3986 fitted with trolley loaded sand approx 100 Cft. 3. One Tractor bearing Registration No. WB55A/8208 (

Mahindra 275DI Red colour) fitted with trolley loaded sand approx 50 Cft.

The fact of the case in brief is that on 21.05.2023, I ASI Manik Ch Mahato along with C/967 Basudeb Singh Mura, HG/1419 Santanu Dutta were engaged night mobile duty vide Manbazar PS GDE No- 1261 & CC No. 1309/23 dated - 21.05.2023. During night mobile duty on 22.05.2023 at about 02:15 hrs. received credible source information that the above noted Tractors engaged for lifting sand illegally from Kanshabati River bed at Basudih River Ghat. After receiving this information I informed the fact to OC Manbazar PS and as per his direction I along with my accompanied force proceeding towards Basudih River Ghat side under Manbazar PS. At about 02:45 hrs while we reached at that anticipated place found the Drivers of the said Tractors are lifting sand into their Tractors. Being found the Police party they fled away after keeping the Tractors there. We searched the said Tractors and found two Tractors loaded with sand approx 100 Cft and other Tractor loaded with sand approx 50 Cft with the position for continuous loading of sand. I searched for any valid documents in respect of sand loaded Tractors but nothing found. Accordingly I seized the Tractor (Blue Color 380 Eicher) having Registration No. WB55A/8366 fitted with trolley loaded sand approx 100 Cft ,Tractor (Red Color 415 DI Dlx Mahindra) having Registration No WB55B/3986 fitted with trolley loaded sand approx 100 Cft. & Tractor bearing Registration No. WB55A/8208 (Mahindra 275DI Red colour) fitted with trolley loaded sand approx 50 Cft. under proper seizure list. Thereafter arranging drivers from my source I brough the said Tractors to Manbazar PS. As such there is every reason to believe that the drivers and owners of th said Tractors which were engaged for transporting & lifting sand illegally without any valid documents i support of carrying/Lifting sand and they deal with the business of stolen sand in a clandestine manner. S they are liable for offence punishable as per law.

Therefore, I pray before you that a specific case may kindly be started against the drivers and owners above mentioned Tractors as per law and arrange for its investigation.
