In producing here with one accused person Subhas Munda (40 yrs) S/O Late Patit Munda of Vill-Golkidih, PS- Manbazar, Dist- Purulia along with following seized articles viz- 08 (Eight) Ltrs. ID liquor within a Plastic Jarikane.

I ASI Pravash Ch Bauri of Manbazar PS do here by lodged a complaint against accused namely Subhas Munda (40 yrs) S/O Late Patit Munda of Vill-Golkidih, PS- Manbazar, Dist-Purulia to the effect that today (30.05.2023) at 17:15 hrs. I received a telephonic information from a reliable source that one Subhas Munda (40 yrs) S/O Late Patit Munda of Vill-Golkidih, PS- Manbazar, Dist- Purulia was stocked ID liquor illegally at his house and selling the same to hike price for his personal gain. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/786 Suchand Mandi and C/1544 Prasenjit Bhattacharjee rushed to the spot for raid by Govt. vehicle. At about 18:05 hrs. myself along with force reached at Golkidih village and held raid in the house of Subhas Munda and found that he is selling ID liquor at the courtyard of his house and Seeing the police party some persons fled away and said Subhas Munda tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Subhas Munda (40 yrs) S/O Late Patit Munda of Vill-Golkidih, PS- Manbazar, Dist-Purulia as per law and arrange for its investigation.
