## Sub: Complaint against Mr. Bhabani Bauri & others

Sir,

This is to bring to your kind notice that I Mithun Adhikary. Son of Ananda Adhikary, am residing at QTR No. SD 1 Near RTPS main gate P.O Nildih pincode 723133 Mobile No- 9563242299, Dist- Purilia, West Bengal-.

That on dated 02.05.2023, an incident took place outside the Raghunathpur Thermal Power Station, DVC Entry Gate No..... During the entry our office staff in the morning. I would like to report the occurrences on record as follows:

On 02.05.2023 the aforementioned Mr. Bhabani Bauri& others obstructed our staffs namely Gobindo Das, Bappaditya Mondal, Manoj Kumar Thakur, kajal Bauri,. Sanjit Mahato, Dinabandhu Pramanik, during their entry to the plant& forcefully snatched their gate passes. They put forward some unjustified demands like - that we have to engage their nominated candidates as an employee.

As aProject manager, I immediately arrived at the spotatter hearing about the incident over the phone and requested him/them,to remove the obstruction, so that our office staffs can join their respective shifts asper their schedule. When I protested and stated my negation regarding his /their unjustified behavior &demands they suddenly attacked me.Started kicking me, held my throat and started to punch on my face. As a result, I fall down on the ground and gotinjured. Thereafter, I was rescued somehow by the help of my co -workers.

Then the aforementioned Mr. Bhabani Bauri & his group threated all of us that he/they will cause harm to our life, family and property outside the RTPS premises and repeatedly given death threats to all of us 10.814530046

Finding no other alternative way, I am writing this application before you that you kindly to take necessary action & please ensure security of us and our family, and start proper investigation regarding the matter.
