Sub:- Complain for starting a specific case .

Sir,

In producing herewith the seized Tractor along with trolley having registration No-WB 41E/0690 loaded with sand approx 80 Cft under proper seizure list. I beg to submit that I, SI Manas Dutta, along with C/1302 Radhagobinda Dhibar and NVF/660 Ranjit Kumbhakar all are of Neturia PS were performing anticrime day mobile duty vide Neturia PS GD No- 848 Dt. 20.05.23 & CC No- 1611/23 Dt. 20.05.23 at PS area and on 20.05.2023 at about 12:05 hrs received a credible source information that one tractor loaded with illegal sand in trolley is parked at Deoli Ghat on the river bed of Damodor river. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately moved towards Deoli Ghat and at about 12:25 hrs reached at Deoli Ghat and found that above noted tractor was parked there and seeing the police team the driver of the said tractor fled away. We chased to apprehend the driver but in spite of hot chase he managed to escape. Then we searched the tractor and found that the vehicle (tractor) having registration No-WB 41E/0690 has been loaded with sand approx 80 Cft.

So, there is reason to believe that the driver and registered owner of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to different area knowing it to be stolen.

Accordingly, I seized the tractor having registration No- WB 41E/0690 along with trolley without registration No. loaded with sand approx 80 C.Ft. at 12:55 hrs to 13:15 hrs under proper seizure list duly signed by witnesses. So, the driver and registered owner of the vehicle have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver and registered owner of vehicle having registration No-WB 41E/0690 U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
