Sub: Complain to start a specific case.

Sir,

In producing herewith one arrested accused person namely Dinesh Kumar Routh (36 years) S/O- Lt. Bhadai Routh of Egarkund South, Nakrakanali, PS-Chirkunda, Dist-Dhanbad, Jharkhand along with one seized Mahindra Bolero Pick-up vehicle bearing registration No- JH 10BT/0765 loaded with 2 MT (Approx) raw coal, do hereby lodge a complaint to the effect that on 28.05.23, I, SI Manas Dutta, along with C/680 Biswanath Roy, C/159 Dinesh Singh Sardar and C/564 Prasad Majee all are of Neturia PS were engaged in evening mobile duty vide Neturia PS GDE No- 1191 Dt. 28.05.2023 & CC No- 1681/23 Dt. 28.05.23. In course of evening mobile duty reached at Maheshnadi check post on Sarbari -Panchet pitch road and started Naka checking there. In the mean time at about 19:30 hrs found that the above noted vehicle was coming from Chirkunda side towards Maheshnadi check post side under Neturia PS. We indicated the vehicle to stop and on checking it was found that coal seems to be steam was loaded inside the vehicle. Then I requested the driver to produce relevant documents/challan/cash memo in respect of loaded coal but he failed to produce any valid documents in support of loaded coal as well as vehicle and also his driving license. On preliminary enquiry and as per statement of the restrained driver it could be learnt that he is the registered owner cum driver of the above noted vehicle and he procured said coal from different illegal coal mines at different area under Jharkhand state.

So, it is reasonable to believe that the above noted accused driver cum registered owner of the said vehicle have obtained the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, he was trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen.

Accordingly, I seized Mahindra Bolero Pick-up bearing registration No- JH 10BT/0765 loaded with raw coal of 2 MT (Approx) under proper seizure list duly signed by available witnesses and also I arrested Dinesh Kumar Routh (36 years) S/O- Lt. Bhadai Routh of Egarkund South, Nakrakanali, PS-Chirkunda, Dist-Dhanbad, Jharkhand (Driver cum owner) in this case. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr PC and brought him to PS with loaded Mahindra Bolero Pick-up. I have also sealed & labelled approx 05 (Five) kg coal as sample from the major contraband on the spot.

Under the above circumstances a specific case may kindly be started against Dinesh Kumar Routh (36 years) S/O- Lt. Bhadai Routh of Egarkund South, Nakrakanali, PS-Chirkunda, Dist-Dhanbad, Jharkhand (Driver cum Owner of the seized vehicle No- JH 10BT/0765) under proper section of law.
