Sub: Prayer for starting a specific case against Ajay Agarwal (42 Years) S/O- Lt. Rameswar Lal Agarwal of Vill-Amdanga, PS-Neturia, Dist-Purulia.

Sir,

In producing herewith the seizure list Dt. 02.05.2023 along with seized 15 MT (approx) steam coal from the courtyard of Ajay Agarwal (42 Years) S/O- Lt. Rameswar Lal Agarwal of Vill-Amdanga, PS-Neturia, Dist-Purulia, I beg to report that on 02.05.23 myself along with C/174 Tapandas Bauri, NVF/578 Niranjan Hembram all are of Neturia PS, Dist-Purulia performing mobile duty at PS area vide Neturia PS GDE No- 49 Dt. 02.05.23 and CC No- 1427/23 Dt. 02.05.23. During mobile duty at about 14:45 hrs received credible source information that huge amount of steam coal was stocked at the courtyard of Ajay Agarwal illegally. I informed the matter to you and as per your kind direction myself along with force left for Amdanga village to work out the information. After reaching there at about 15:25 hrs, I found that huge quantity of steam coal was stocked at courtyard of Ajay Agarwal. We searched for anyone nearby surrounding area of courtyard but neither Ajay Agarwal nor his any family member turned up before me. There is strong reason to believe that Ajay Agarwal procured and stocked the said coal either by theft or by any fraudulent means after hatching a criminal conspiracy and he was trying to dispose of the same coal in a clandestine manner to different areas knowing it to be stolen.

Accordingly, I seized steam coal weighing about 15 MT and out of it 05 kg as sample under proper seizure list duly signed by available witnesses and necessary arrangement has been made for shifting the seized steam coal at Neturia PS.

I, therefore, pray before you kindly lodge an FIR against Ajay Agarwal (42 Years) S/O- Lt. Rameswar Lal Agarwal of Vill-Amdanga, PS-Neturia, Dist-Purulia as per law and arrange for its investigation.
